

## THE TEVIOT ELECTRIC-POWER BOARD

## RESOLUTION MAKING SPECIAL RATE

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Teviot Electric-power Board hereby resolves as follows:—

"That for the purpose of providing the interest and other charges on a loan of £24,900 authorized to be raised by the Teviot Electric-power Board under the above-mentioned Act, for the purpose of redeeming on the 1st November, 1950, debentures amounting to £24,900 issued by the Board pursuant to the provisions of the Teviot Electric-power Board Loans Conversion Order 1934 (which constitute the balance of this loan), the said Teviot Electric-power Board hereby makes and levies a special rate of twopence halfpenny (2½d.) in the pound (£) upon the rateable value (on the basis of the capital value) of all rateable property within the Teviot Electric-power District, comprising the whole of the Borough of Roxburgh and part of the County of Tuapeka; and that such special rate shall be an annual-recurring rate during the currency of such loan and be payable half-yearly on the 1st day of May and the 1st day of November in each and every year during the currency of such loan, being a period of ten (10) years, or until the loan is fully paid off."
