TAIHAPE BOROUGH COUNCIL

RESOLUTION MAKING SPECIAL RATE

N pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Taihape Borough Council hereby resolves as follows:-

"That, for the purpose of providing the interest and other charges on a loan of £500, authorized to be raised by the Taihape Borough Council under the above-mentioned Act, for the purpose of completing the works for which the Housing Loan, 1947, £11,000, was authorized, the said Taihape Borough Council hereby makes and levies a special rate of forty-three one-thousandths of a penny (-043d.) in the pound upon rateable value of all rateable property of the Borough of Taihape, and that such special rate shall be an annually recurring rate during the currency of such loan, and be payable yearly on the 1st day of August in each and every year during the currency of such loan. being a period of thirty years or until the loan currency of such loan, being a period of thirty years or until the loan is fully paid off."
