W HEREAS the land described in the Schedule hereto forms portion of a reserve duly set apart for scenic purposes : And whereas the said land is no longer suitable for scenic purposes by reason of the absence of bush of scenic value thereon : Now, therefore, I, Lieutenant-General Sir Bernard Cyril Frey-berg, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section 8 of the Scenery Preservation Amendment Act, 1910, do hereby revoke the reservation for scenic purposes over the land described revoke the reservation for scenic purposes over the land described in the Schedule hereto.
