## RESOLUTION MAKING SPECIAL RATE

## Water Reticulation Loan, 1951, £20,000

**IN** pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Health Act, 1920, and the Municipal Corporations Act, 1933, and in pursuance and exercise of all other powers and authorities enabling it in that behalf the Ashburton Borough Council hereby resolves as follows :—

"That, for the purpose of providing the interest and other charges on a special loan of £20,000, authorized to be raised by the Ashburton Borough Council under the above-mentioned Acts, for the purpose of providing water reticulation in portions of the Ashburton Borough, hereby makes and levies a special rate of twopence (2d.) in the pound upon the rateable property (on the basis of annual value) of all rateable property in the Borough of Ashburton and that such special rate shall be an annually recurring rate during the currency of such loan and be payable on the 1st day of April in each and every year during the currency of such loan, being for a period of twenty-five years or until the loan is fully paid off."
