(3) The said loan or any part thereof shall be repaid by equal annual instalments of principal extending over the term of the loan as determined in (1) above.
(4) The payment of interest and the repayment of principal

(6) The rate payable either as interest or as principal in respect of the said loan shall be paid out of loan-moneys. (6) The rate payable for brokerage, underwriting, and pro-cutation fees in respect of the raising of the said loan or any part thereof shall not in the aggregate exceed one-half per centum of one of the said loan of the said loan or any part any amount raised.
