A PROCLAMATION

IN pursuance and exercise of the power and authority conferred upon me by subsection (1) of section 8 of the Housing Amendment Act, 1940, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare the land described in the Schedule hereto, being land subject to the Housing Act, 1919, to be Crown land available for reservation under the Land Act, 1948.

SCHEDULE

SOUTHLAND LAND DISTRICT

ALL that area containing by admeasurement 2 acres 3 roods 25·3 perches, more or less, being Lots 1-7 and 10-16, as shown on a plan deposited in the Land Registry Office at Invercargill under No. 4319, being part Section 15, Block I, Campbelltown Hundred, and being part of the land comprised and described in Certificate of Title, Volume 151, folio 273 (Southland Registry); subject to drainage easement created by Transfer No. 73275 in favour of Bluff Borough Council.

*Revoking the Reservation Over Portion of a Scenic Reserve in the Nelson Land District*

A PROCLAMATION

WHEREAS the land described in the Schedule hereto forms portion of a reserve duly set apart for scenic purposes: And whereas the said land is no longer suitable for scenic purposes by reason of the absence of bush of scenic value thereon: Now, therefore, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section 8 of the Scenery Preservation Amendment Act, 1910, do hereby revoke the reservation for scenic purposes over the land described in the Schedule hereto.

SECTION 16, Block XV, Lyell Survey District: Area, 2 acres 1 rood 32 perches, more or less. (S.O. plan 9674.)
