Proclaiming a Road-line Laid Out in Block XVI, Kawakawa Survey District, and Block IV, Motatau Survey District, North Auckland Land District, to be a Public Road

WHEREAS the land described in the Schedule hereto was, by an order of the Maori Land Court made on the 18th day

of February, 1941, duly laid out as a road-line in pursuance of sections 162, 478, and 479 of the Maori Land Act, 1931:

And whereas the said Court is of the opinion that it is in the public interest that the said road-line should be proclaimed as a public road, and a notification to that effect has been forwarded to

the Minister of Lands, in terms of section 486 of the said Act:

And whereas one month's notice in writing of the intention to proclaim the said road-line as a public road has been given by the Surveyor-General to the local authority of the district concerned, in terms of subsection (2) of section 487 of the said Act:

And whereas it is now expedient that the said road-line should be proclaimed as a public road:

Now, therefore, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred by section 487 of the Maori Land Act, 1931, do hereby proclaim as a public road the road line described in the Schedule hereto. the road-line described in the Schedule hereto.

Land Set Apart as Provisional State Forest Declared to be Subject to the Land Act, 1948

[L.S.] B. C. FREYBERG, Governor-General A PROCLAMATION

In pursuance and exercise of the powers and authorities conferred upon me by subsection (2) of section 19 of the Forests Act, 1949, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, acting on the joint recommendation of the Minister of Lands and of the Minister of Forests, do hereby proclaim and declare that the land described in the Schedule hereto, being part of a provisional State forest reserve set apart by Proclamation dated the 5th day of July, 1920, and gazetted on the 8th day of that month, is required for settlement nurposes: and in accordance with the provisions of the settlement nurposes: and gazetted of the son day of that month, is required for settle-ment purposes; and, in accordance with the provisions of the said Act, such land shall, from and after the day of the gazetting hereof, cease to be provisional State forest land, and shall become Crown land available for sale, lease, reservation, or other disposition under the provisions of the Land Act, 1948.
