Declaring Lands in South Auckland, Wellington, and Otago Land Districts Vested in the Auckland, Wanganui, and Otago Education Boards as Sites for Public Schools, to be Vested in His Majesty

A PROCLAMATION

WHEREAS by subsection (6) of section 5 of the Education

WHEREAS by subsection (6) of section 5 of the Education Lands Act, 1949 (hereinafter referred to as the said Act), it is provided that, notwithstanding anything contained in any other Act, the Governor-General may from time to time, by Proclamation, declare that any school-site or part of a school-site which in his opinion is no longer required for that purpose shall be vested in His Majesty; and thereupon the school-site, or part thereof, as the case may be, shall vest in His Majesty freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date of the proclamation:

Now, therefore, pursuant to subsection (6) of section 5 of the said Act, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the First Schedule hereto, being an area vested in the Auckland Education Board, the land described in the Second Schedule hereto, being an area vested in the Wanganui Education Board, and the lands described in the Third Schedule hereto, being areas vested in the Otago Education Board, as sites for public schools, shall be vested in His Majesty the King, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date hereof. the same at the date hereof.

FIRST SCHEDULE SOUTH AUCKLAND LAND DISTRICT
