

Now, therefore, pursuant to subsection (6) of section 5 of the said Act, I, Bernard Cyril, Baron Freyberg, the Governor-General of New Zealand, do hereby proclaim and declare that the land described in the First Schedule hereto, being an area vested in the Auckland Education Board, the land described in the Second Schedule hereto, being an area vested in the Canterbury Education Board, the lands described in the Third Schedule hereto, being areas vested in the Otago Education Board, and the land described in the Fourth Schedule hereto, being an area vested in the Southland Education Board, as sites for public schools, shall be vested in Her Majesty the Queen, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date hereof.

A PROCLAMATION

PURSUANT to section 20 of the Forests Act 1949, I, Bernard Cyril, Baron Freyberg, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as a forest sanctuary.

#### SCHEDULE

##### NORTH AUCKLAND LAND DISTRICT—AUCKLAND CONSERVANCY

##### *Waipoua Forest Sanctuary*

ALL that area in the North Auckland Land District, containing approximately 22,500 acres, situated in Blocks XIV, XV, and XVI, Waoku Survey District, and Blocks II, III, IV, VI, VII, and VIII, Waipoua Survey District, being part of Waipoua State Forest, and bounded generally as follows: Towards the north by Sections 23 and 32, Block XIV, Waoku Survey District, the Dargaville-Ohaeawai State Highway, Section 9 and Lot 2 of Section 6, Block XIV aforesaid, and Sections 1, 12, 13, and 14, Block XV, Waoku Survey District; towards the east by Sections 8, 9, 10, and 11, Block XV, aforesaid; towards the north by Section 11 aforesaid and Sections 22 and 18, Block XVI, Waoku Survey District; towards the east generally by the Waoku Road, Sections 19, 20, 21, 22, 22A, 23, 13, and 30, Block VIII, Waipoua Survey District, and the Waima River; towards the south generally by Sections 31 and 25, Block VIII, aforesaid, a public road, and Sections 9, 6, and 4, Block VII, Waipoua Survey District; towards the west generally by the Kawerua Road, 3920 links; thence by lines bearing 17° 15', 285 links; 29° 15', 232 links; 7° 15', 505 links; 333° 15', 489 links; 343° 15', 333 links; 352° 15', 350 links; 329° 15', 349 links; 1° 15', 1487 links; 36° 15', 1299 links; 37° 45', 1200 links; 90° 15', 283 links; 64° 15', 236 links; 36° 45', 835 links; 66° 45', 367 links; 77° 15', 250 links; 87° 15', 382 links; 68° 15', 457 links; 15° 30', 255 links; 23° 15', 264 links; 87° 15', 364 links; 23° 45', 593 links; thence by a line due north for 3700 links to and across the Waipoua River; thence towards the south-west generally by the northern bank of the Waipoua River for 36000 links; thence towards the west generally by lines bearing 357°, 7280 links; 305°, 12525 links, and 22°, 12860 links to a point on the southern boundary of Section 23, Block XIV, aforesaid, and distant 600 links from the south-eastern corner of that section. Save and excepting a gravel reserve in Block XIV aforesaid and all public roads. As the same is more particularly delineated on plan No. 7/39, deposited in the Head Office of the New Zealand Forest Service at Wellington, and thereon bordered red.
