*The Upper Hutt Licensing Trust Constitution Notice 1952*

PURSUANT to the Licensing Trusts Act 1949 and the Local Licensing Trusts Regulations 1949, the Minister of Justice hereby gives notice as follows.

NOTICE

1. This notice may be cited as the Upper Hutt Licensing Trust Constitution Notice 1952.
2. There is hereby constituted a local licensing Trust, to be called the Upper Hutt Licensing Trust.
3. (1) The first election of members of the Trust shall be held on Saturday the 23rd day of August 1952.  
(2) The Returning Officer for the first election of members of the Trust shall be Bertram Matthew Wilmshurst, Town Clerk of the Upper Hutt Borough Council.
4. The area within which polls shall be taken for elections of members of the Trust shall be the whole of the area within the boundaries of the Borough of Upper Hutt as from time to time constituted.
5. The area within which the Trust may expend or distribute profits pursuant to subsection (1) of section 44 of the Licensing Trusts Act 1949 shall be the whole of the area within the boundaries of the Borough of Upper Hutt as from time to time constituted.

*The Servicemen's Settlement Act 1950—Notice Declaring Land Taken for Settlement of Discharged Servicemen*
