A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Bernard Cyril, Baron Freyberg, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 29th day of March 1952 and published in the *New Zealand Gazette* No. 25 of the 3rd day of April 1952, at page 454, taking land for housing purposes and for the purposes of a pleasure-ground in the City of Wellington, and hereby proclaim and declare that the land described in the First Schedule hereto is hereby taken for housing purposes, that the land described in the Second Schedule hereto is hereby taken for the purposes of a pleasure-ground, and that the said parcels of land shall vest in the Mayor, Councillors, and Citizens of the City of Wellington as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 11th day of August 1952.
