RESOLUTION MAKING SPECIAL RATE

IN pursuance and exercise of the powers vested in it in that behalf by the Meat Act 1939 and amendments, the Local Bodies' Loans Act 1926, the Local Bodies' Loans Amendment Act 1951, the Local Government Loans Board Act 1926 and regulations thereunder, and of all other powers thereunto enabling it the Auckland City Council hereby resolves as follows:—

"That, for the purpose of providing interest and other charges on an amount of eleven thousand pounds (£11,000) to be known as the Municipal Abattoir Improvement Loan 1952, which amount is proposed to be raised by the Auckland City Council under the above-mentioned Acts for the purpose of installing at the municipal abattoir an alternator and voltage regulator, and outloading conveyer (slat type), providing a conveyer from the new beef house to the existing chill rooms, completing the construction of new chill rooms, and meeting the cost of raising the loan, the said Auckland City Council hereby makes and levies a special rate of one-twentieth of a penny ($\frac{1}{20}$ d.) in the pound (£) upon the rateable value (upon the basis of the annual value) of all rateable property in the City of Auckland, and that the said special rate shall be an annual-recurring rate during the currency of such loan and shall be payable yearly on the 1st day of June in each and every year during the currency of the said loan or until the loan is fully paid off."

SOUTH CANTERBURY CATCHMENT BOARD

RESOLUTION MAKING SPECIAL RATE

Ophi Flood Damage Restoration Amalgamated Loan 1952, of £21,250

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act 1926 and section 70 of the Soil Conservation and Rivers Control Act 1941 the South Canterbury Catchment Board hereby resolves as follows:—

"That, for the purpose of providing the interest and other charges on the amalgamated loan of £21,250 under the above-mentioned Acts for flood-damage restoration on the Ophi River and its tributaries, the said South Canterbury Catchment Board hereby makes and levies a special rate of 0.7d. on lands classed A, of 0.56d. on lands classed B, of 0.42d. on lands classed C, of 0.21d. on lands classed D, of 0.14d. on lands classed E, of 0.07d. on lands classed F upon the rateable capital value of all rateable property in the Ophi River Special Rating District as defined in the Schedule attached hereto, and that such special rate shall be an annual-recurring rate during the currency of such loan, being a period of fifteen (15) years, or until the loan is fully paid off."

The above resolution was duly passed at a meeting of the South Canterbury Catchment Board held on Thursday, 14 August 1952 and confirmed at a meeting held on Thursday, 11 September 1952.

SCHEDULE OF BOUNDARIES OF OPHI RIVER SPECIAL RATING DISTRICT

ALL that area in the Canterbury Land District of approximately 700 square miles, bounded by a line commencing at a point on the sea-coast in line with the centre line of Springs Road, forming the southern boundary of R.S. 14595 and Sections 13, 4, 22, 23 of Kereta Settlement, Block IX, Arowhenua Survey District; thence westerly by a line along the said Springs Road to the junction of that road with Seadown Road; thence westerly along a public road forming the southern boundary of R.S. 14476 to the South Island Main Trunk Railway Reserve; thence by a right line across the said railway reserve to and along a public road to the junction of that said road with the Picton-Bluff State Highway; thence westerly along Falveys Road forming the southern boundary of R.S. 19697 to its junction with Brosnans Road; thence northerly along the eastern boundary of R.S. 19746 for a distance of 10½ chains; thence westerly along the northern boundary of a triangular 2 acre reserve forming part of R.S. 19746 to a point on Brosnans Road 10 chains from the said junction with Falveys Road; thence northerly along Brosnans Road to a point at the easternmost corner of R.S. 21486, Block V, Arowhenua Survey District; thence south-westerly along the boundary of R.S. 21486 and 21508 to the southernmost corner of R.S. 21486; thence north-westerly along the boundary of R.S. 21486 and 21496 to a point on the Levels Plains Middle Road; thence south-westerly along that road to its junction with Falveys Road and Foleys Road; thence northerly along the said Foleys Road to its junction with Pound Road; thence westerly along the said Pound Road to its junction with Kerrytown Road; thence northerly along the said Kerrytown Road to a point at the south-easternmost corner of R.S. 21234; thence westerly along the boundary of R.S. 21234 and 22817 to a point on the boundary of R.S. 18036; thence northerly along the boundary of R.S. 21234 and 18036 to the easternmost point on the boundary of R.S. 18035; thence north-westerly along the boundary of R.S. 21234, 18590, and 18035 to the northernmost point of R.S. 18035; thence south-westerly along the north-western boundary of R.S. 18035 to the westernmost corner of R.S. 18035; thence north-westerly along the south-western boundary of R.S. 17589, 18490, 16749 to a point on Stonyers Road; thence northerly along Stonyers Road to the south-westernmost corner of Reserve 1584; thence in an easterly direction

along the southern boundary of Reserve 1584 to its south-easternmost corner; thence northerly along the eastern boundary of Reserve 1584 to its north-easternmost corner; thence westerly along the northern boundary of Reserve 1584 to a point on Stonyers Road; thence northerly along Stonyers Road to a point on the south-easternmost corner of R.S. 17506; thence westerly along the southern boundary of R.S. 17506; thence westerly along the southern boundary of R.S. 17506 to the west-southernmost corner of R.S. 17506; thence north-westerly along the south-western boundary of R.S. 17506 to south-westernmost corner of R.S. 17506; thence northerly along the western boundary of R.S. 17506 to a point on Pleasant Point-Temuka Main Highway; thence westerly along that highway to its junction with the Timaru-Cromwell State Highway; thence westerly along the said State Highway to the easternmost corner of R.S. 14284; thence south-westerly along the eastern boundary of R.S. 14284 and R.S. 13743 to the southernmost corner of R.S. 13743; thence north-westerly along the south-west boundary of R.S. 13743 to a point on Keanes Road, Block VIII, Pareora Survey District; thence generally north-easterly along that road to a point on the east-northernmost corner of R.S. 13744; thence southerly along the eastern boundary of R.S. 12242 and R.S. 13744 to the southernmost corner of R.S. 12242; thence north-westerly along the southern boundary of R.S. 12242 to its westernmost corner; thence southerly along the boundary of R.S. 11121 and R.S. 13744 to the southernmost corner of R.S. 11121; thence westerly along the southern boundary of R.S. 11121 to its westernmost corner; thence south-westerly along the south-eastern boundaries of Lots 1 and 2, D.P. 396, to a point on Downs Road; thence southerly along that said Downs Road to the south-easternmost corner of R.S. 14780; thence westerly along the southern boundaries of R.S. 14780 and R.S. 16759 to the westernmost point of R.S. 16759; thence south-westerly by a right line across R.S. 15830 and R.S. 16675 to the southernmost corner of Lot 1, D.P. 950; thence south-easterly along the eastern boundary between Lot 1, D.P. 667 and D.P. 951 to the easternmost corner of D.P. 951; thence south-westerly along the southern boundaries of D.P. 951 and Lot 101, Rosewill Settlement, to a point on a public road at the westernmost corner of Lot 1, D.P. 3881; thence generally southerly, south-westerly, and westerly along that said public road to its junction with Sutherlands Road; thence northerly along Sutherlands Road, Block X, Pareora Survey District, to its junction with a public road at the northernmost point on Lot 92, Rosewill Settlement; thence generally westerly, northerly, and north-westerly and south-westerly along that said public road to its junction with a road at the north-westernmost point of Reserve 2457; thence north-westerly along that said public road to the easternmost corner of R.S. 20263; thence generally southerly, westerly, and south-westerly along the southern boundary of R.S. 20263 to a point on the Timaru-Cave Main Highway; thence westerly along that said main highway to the easternmost corner of part Lot 86, Rosewill Settlement; thence westerly along the northern boundary of Lot 87 to a point on Limestone Valley Road; thence generally southerly along that road to its junction with a road joining a public road and Limestone Valley Road passing through and between Lots 83 and 84, Rosewill Settlement; thence along that said road to its junction with that said public road; thence generally northerly and westerly along that said public road to the northernmost boundary between Lots 82 and 83, Rosewill Settlement, on that said public road; thence generally south-westerly and westerly along the boundary between Lots 82 and 83, Rosewill Settlement, to a point on eastern boundary of R.S. 30257; thence northerly along the eastern boundaries of R.S. 30257 and R.S. 31399 to the north-easternmost point of R.S. 31399; thence westerly along the northern boundary of R.S. 31399 to the south-easternmost point of R.S. 33506; thence northerly along the eastern boundary of R.S. 33506 to its north-easternmost corner; thence westerly along the northern boundary of R.S. 33506 to its north-westernmost corner; thence southerly along the western boundary of R.S. 33506 to the northernmost point of R.S. 30443; thence westerly along the northern boundary of R.S. 30443 to the southernmost point of Lot 77, Rosewill Settlement; thence generally northerly and westerly along the boundary between Lots 76 and 77, Rosewill Settlement, to the northernmost corner of Lot 76, Rosewill Settlement; thence south-westerly along the southern boundaries of Lots 74 and 73, Rosewill Settlement, to the easternmost corner of Lot 75, Rosewill Settlement; thence generally north-westerly along the north-eastern boundary of Lot 75 to Cannington Road at the south-westernmost corner of Lot 71, Rosewill Settlement; thence across Cannington Road and proceeding generally westerly, northerly, and southerly along the watershed between the Pareora River and the Tengawai River passing through Trig. Station E. 99, Block VIII, Opawa Survey District, and Trig. Station Q, Block XI, Opawa Survey District, to Trig. Station A. 163, Blocks XI and X, Opawa Survey District; thence generally westerly, northerly, and southerly along the watershed between Pareora River and Rocky Gully Stream (Tengawai River tributary) across R.S. 36054, Sections 11 and 9, Mount Nessing Settlement, Blocks X and XIV, Opawa Survey District, to the southernmost corner of Section 8, Mount Nessing Settlement, Blocks X, XIII, and XIV, Opawa Survey District; thence proceeding generally northerly and westerly along the western boundaries of that Section and by Section 2, Mount Nessing Settlement, Block IX, Opawa Survey District, along the summit of Hunters Hills, the watershed between the Hakataramea River, the Opawa River, and Exe Creek to the southern boundary of R.S. 36478; thence westerly along that boundary and the watershed between the source of the Hakataramea River aforesaid and Lockhart's Creek to the summit of Dalgety Range; thence northerly along that range, passing through Trig. Station B, Block XV, Burke Survey District, to and across Mackenzie Pass at the south-eastern corner of R.S. 36814; thence along the watershed between Gray's River, Mackenzie Stream, and Avalanche Stream to Trig. Station D, Block XI, Burke Survey District; thence generally northerly along the summit of Rollesby Range, through Burke's Pass, along the watershed between Sawdons Stream and Ophi River, passing through Mount Burgess, Block IV, Burke Survey District, and continuing
