EYRE COUNTY COUNCIL

RESOLUTION MAKING SPECIAL RATE

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act 1926, the Eyre County Council hereby resolves as follows:—

"That, for the purpose of providing the interest and other charges on a loan of £10,000, authorized to be raised by Eyre County Council under the above-mentioned Act for the erection of staff houses, the said Eyre County Council hereby makes and levies a special rate of one hundred and forty-six one-thousandths ($\frac{146}{1000}$) pence in the pound upon the rateable capital value of all rateable property in the whole of the County of Eyre; and that such special rate shall be an annual-recurring rate during the currency of such loan and be payable yearly on the 1st day of April in each and every year during the currency of such loan, being a period of twenty-five years, or until the loan is fully paid off."
