Proclaiming Maori Land to be Vested in Her Majesty the Queen

A PROCLAMATION

PURSUANT to section 450 of the Maori Land Act 1931, I, Sir Humphrey Francis O'Leary, the Administrator of the Govern-ment of New Zealand, hereby proclaim and declare that the Maori land described in the Schedule hereto is vested in Her Majesty the Queen.

SCHEDULE

SOUTH AUCKLAND LAND DISTRICT

ALL those areas containing by admeasurement 1,255 acres, more or less, situated in Block XIV, Puketapu Survey District, and Blocks I, II, and III, Maungaku Survey District, being parts of Puketapu No. 3A Block, and being part of the land comprised and described in certificate of title, Volume 382, folio 199 (Auckland Land Registry).

As the same is more particularly delineated on the plan marked M.A. 1919/1, deposited in the Head Office of the Department of Macri Afrirs at Wellington and thereon edged red

PURSUANT to section 18 of the Forests Act 1949, I, Sir Humphrey Francis O'Leary, the Administrator of the Govern-ment of New Zealand, hereby set apart the Crown land described in the Schedule hereto as permanent State forest land.
