WHEREAS by Order in Council made on the 14th day of May W 1952 (hereinafter called the said Order in Council) and subject to the determinations as to borrowing and repayment therein set out, consent was given to the raising in New Zealand by the Taupo Town Board (hereinafter called the said local authority) of a loan of thirty-seven thousand pounds (£37,000) to be known as "Hydro-electric Power Supply Additional Loan 1952" (herein-after called the said loan). after called the said loan):

And whereas the said loan has not yet been raised and it is expedient to vary certain of the determinations aforesaid in respect of a portion thereof amounting to five thousand pounds $(\pounds 5,000)$ (hereinafter called the said sum) :

Now, therefore, pursuant to section 11 of the Local Government Loans Board Act 1926, as set out in section 29 of the Finance Act 1932 (No. 2), His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby varies certain of the determinations aforesaid in respect of the said sum by prescribing as follows :---

1. In lieu of a term of thirty (30) years, as specified in clause 1 of the said Order in Council, the term for which the said sum or any part thereof may be raised shall not exceed twenty-five (25) years.

2. In lieu of the determinations as to repayment contained in clauses 3 and 4 of the said Order in Council, the following determinations shall apply :-

- (i) The said sum or any part thereof shall be free of principal repayments during the first two years from the date of borrowing thereof.
- (ii) Thereafter the said sum or any part thereof, together with interest thereon, shall be repaid by equal aggregate annual or half-yearly instalments extending over the over the said sum of the said sum balance of the term amounting to twenty-three (23) vears.
