(c) If any lot of eggs sold or offered for sale comprises some eggs classifiable as "Large" and some classifiable as "Small" all the eggs in the lot shall be classified as " Mixed ".

Subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any producer, wholesaler, or retailer, may authorize special prices in respect of any eggs to which this Order applies where special circumstances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the producer, whole-saler, or retailer. Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of eggs or may relate generally to all eggs to which this Order applies sold by the producer, wholesaler, or retailer while the approval remains in force. remains in force.

## RETAILERS TO EXHIBIT PRICES

10. Every retailer who offers or exposes any eggs to which this Order applies for sale in any shop shall keep in a prominent position in such proximity to the eggs to which it relates as to be obviously descriptive thereof a ticket, placard, or label on which shall be stated in legible and prominent characters the classification of the eggs and the metal prior per decom the retail price per dozen.
