WHEREAS it is provided by section 3 of the Rotorua Borough Council Reclamation Empowering Act 1931 (hereinafter called the said Act), that the Rotorua Borough Council may, subject to section 171 of the Harbours Act, 1923 (now section 178 of the Harbours Act 1950), reclaim from the waters of Lake Rotorua the whole or any parts of the area described in the Schedule to the said Act:

And whereas the Rotorua Borough Council (hereinafter called the Council) was by Order in Council dated the 7th day of May 1941, authorized to reclaim certain land from the waters of Lake Rotorua, as shown on the approved plan marked M.D. 8079, and deposited in the office of the Marine Department at Wellington:
