Price Order No. 1485 (Amendment No. 2 of Price Order No. 1467) (Eggs)

DURSUANT to the Control of Prices Act 1947, the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, hereby makes the following amending Price Order :

1. This Order may be cited as Price Order No. 1485, and shall be read together with and deemed part of Price Order 1467* (hereinafter referred to as the principal Order).

2. This Order shall come into force on the 3rd day of August 1953.

3. The principal Order is hereby amended by revoking the First and Second Schedules thereto, and substituting the following Schedules:
