RESOLUTION MAKING SPECIAL RATE

Waterworks Supplementary Loan 1953 (£35,000)

THE Christchurch City Council at a meeting held on the 3rd day of August 1953 passed the following resolution:

In pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act 1926 and its amendments and all other powers it in that behalf enabling, the Christchurch City Council hereby resolves as follows:

''That, for the purpose of providing the principal, interest, and other charges on a loan of thirty-five thousand pounds (£35,000) authorized to be raised by the Christchurch City Council under the above-mentioned Act for the purpose of providing waterworks for the improvement of the water supply of the City of Christchurch, the said Christchurch City Council hereby makes and levies a special rate of four hundred and fifty-nine twelve thousand five hundredths of a penny (450/12500d.) in the pound (£0.000153) on the rateable value (on the basis of the unimproved value) of all rateable properties comprised within the City of Christchurch; and that such special rate shall be an annually recurring rate payable on demand in each and every year during the currency of the said loan, being a period of fifteen (15) years, or until the loan is fully paid off.''
