

Releasing Land from the Provisions of Part XXIV of the Maori Affairs Act 1953 (Te Kao Development Scheme)

PURSUANT to section 332 of the Maori Affairs Act 1953, the Board of Maori Affairs hereby declares that on the date of the publication of this notice in the *Gazette* the land described in the Schedule hereto shall cease to be subject to the provisions of Part XXIV of the Maori Affairs Act 1953, the said land being so subject by virtue of a notice dated 24 August 1938 and published in the *Gazette*, 25 August 1938, Vol. II, page 197.
