

*Authorizing the Laying Off of a Street Off River Road in the City of Hamilton, Subject to a Condition as to the Building Line*

ORDER IN COUNCIL

At the Government House at Wellington this 25th day of May 1955

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

**P**URSUANT to section 186 of the Municipal Corporations Act 1954 and section 125 of the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby authorizes the Hamilton City Council to permit the laying off of the proposed street described in the Schedule hereto at a width for part of its length of less than 66 ft., but not less than 40 ft., subject to the condition that no building or part of a building shall at any time be erected on the land shown edged green on the plan referred to in the said Schedule within a distance of 35 ft. from the centre line of the said street.

#### SCHEDULE

THAT proposed street in the South Auckland Land District, City of Hamilton, containing by admeasurement 32 perches, more or less, being part Lot 1, D.P. 11662, and part Lot 4, D.P. 11279, being part Allotment 219, Kirikiriroa Parish.

As the same is more particularly delineated on the plan marked P.W.D. 146630 deposited in the office of the Minister of Works at Wellington, and thereon coloured red.
