APPLICATION OF THIS ORDER

3. This Order applies with respect to all cocoa, except "Van Houten's" sold in New Zealand.

FIXING MAXIMUM PRICES OF COCOA TO WHICH THIS ORDER APPLIES Wholesalers' Prices

4. (1) Subject to the following provisions of this clause, the maximum price that may be charged or received by any whole-saler (which term in this order shall be deemed to include a manufacturer selling to a retailer) for any cocoa to which this Order

(2) If in respect of any lot of cocoa sold by a retailer the maximum price calculated in accordance with the foregoing provisions of this clause is not an exact number of pence or halfnext upward halfpenny.

GENERAL

6. Notwithstanding the provisions of this Order, the maximum price that may be charged by any wholesaler or by any retailer for cocca to which this Order applies, bought by the whole-saler or by the retailer before the date of coming into force of this Order and unsold by him at that date, shall not exceed the appropriate price authorized pursuant to the Control of Prices Act 1947, to be charged immediately before that date. In the case of cocca to which this Order applies bought by a wholesaler or by a retailer after the coming into force of this Order at the appropriate price authorized pursuant to the Control of Prices Act 1947, to be charged immediately before that date, such cocca shall not be resold at prices in excess of those so authorized prior to the coming into force of this Order. coming into force of this Order.
