

Declaring Portion of Brighton Domain to be a Recreation Reserve Subject to Part II of the Reserves and Domains Act 1953 and Revoking the Reservation Over the Said Land

PURSUANT to the Reserves and Domains Act 1953, the Minister of Lands hereby declares that the portion of the Brighton Domain described in the Schedule hereto shall cease to be subject to Part III of the Reserves and Domains Act 1953, and shall be deemed to be a recreation reserve subject to Part II of that Act, and further, revokes the reservation for recreation purposes over the said land.

Rangitaiki Land Drainage District—Notice of Intention to Make and Levy General Rates

NOTICE is hereby given that it is intended, pursuant to the Rangitaiki Land Drainage Act 1910 and its amendments, to make and levy, on the unimproved value of all land within the district constituted under the said Act, the general rates to meet maintenance costs for the period 1 April 1955 to 31 March 1956, as described in the Schedule hereto.
