RESOLUTION MAKING SPECIAL RATE

THE following resolution was passed by the Feilding Borough Council at a meeting held on the 29th day of June 1955:

"In pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act 1926, the Feilding Borough Council hereby resolves as follows:

"That, for the purpose of providing interest and other charges on the loan of £20,000 (being portion of the Civic Centre Building Loan of £40,000, 1954), authorized to be raised by the Feilding Borough Council under the above-mentioned Act for the purpose of meeting a portion of the cost of erecting and furnishing a civic centre building, the said Feilding Borough Council hereby makes and levies a rate of decimal three one six pence (0.316d.) in the pound upon the rateable value (on the basis of unimproved value) of all rateable property within the Borough of Feilding; and that such special rate be an annual-recurring rate during the currency of such loan, being a period of ten years, or until the loan is fully paid off."
