1. This order may be cited as Price Order No. 1642, and shall be read together with and deemed part of Price Order No. 1616* (hereinafter referred to as the principal order).

2. This order shall come into force on the 27th day of February 1956.

3. The principal order is hereby amended by revoking clauses 7 and 8 thereof, and substituting the following clauses:
