DURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following amending Price Order:

- 1. This order may be cited as Price Order No. 1646, and shall be read together with and deemed part of Price Order No. 1615* (hereinafter referred to as the principal order).
 - 2. This order shall come into force on the 19th day of March 1956.
 - 3. The principal order is hereby amended by revoking the First and Second Schedules thereto, and substituting the following Schedules:
