

line bearing due south across the said Waimata River to the left bank thereof; thence in a south-easterly direction generally along the left bank of the aforesaid Waimata River to a point in line with the middle of Owen Road; thence in a south-easterly direction along the middle of the said Owen Road to the middle of Tyndall Road; thence south-westerly along the middle of the said Tyndall Road to the middle of the Wainui Road; thence north-westerly along the middle of the said Wainui Road to a point in line with the northernmost boundary of subdivision Kaiti 335B Block; thence south-westerly to and by the western boundaries of said Kaiti 335B and Kaiti 335C Blocks to a point on the said western boundary in line with the production of the south-western side of Oman Street; thence in a north-westerly direction by that line across subdivision Kaiti 326 Block to the south-eastern side of Montrose Street; thence south-westerly generally by the said south-eastern side of Montrose Street, by the northern and western boundaries of part subdivision Kaiti 327 Block and by the western boundary of Lot 1, D.P. 3559, to and across Norwood Road and by the western boundaries of Lot 1, D.P. 3631, Lot 1, D.P. 3977, and the north-western boundary of subdivision Kaiti 322 Block and that boundary produced to the mean high-water mark of the sea; thence north-westerly generally along the mean high-water mark of the sea to its intersection with the Gisborne Harbour Break-water; thence westerly by a right line bearing approximately 270° across the Harbour entrance to the Groyne; thence north-westerly across the Groyne and by the mean high-water mark of the sea to the Turanganui River retaining wall; thence north-westerly across the retaining wall and the Turanganui River to the southernmost corner of Waiohiora 2 X Block, S.O. Plan 736, being a point on the high-water mark of the sea; thence westerly generally by the mean high-water mark of the sea to the south-easternmost corner of Awapuni No. 2 Block; thence north-westerly by the north-eastern boundary of the said Awapuni No. 2 Block, to and across the Centennial Marine Drive, and again by the said north-eastern boundary and the north-eastern side of a public road to and across Awapuni Road and by the north-eastern boundary of Awapuni 1A 1 Block across Lytton Road and by the north-eastern boundary of part 1L Block to the right bank of the Waikanāe Stream; thence in a north-easterly direction by the right bank of the aforesaid stream to its intersection with the western side of Lytton Road; thence north-easterly by the western side of said Lytton Road to a point in line with the southern boundary of Scott Street produced; thence north-westerly by this line to the southernmost corner of said Scott Street being the easternmost corner of Lot 53, D.P. 2121; thence westerly generally by the southern boundaries of said Lot 53, of Kent Street, and of Lots 52, 51, 50, 49, 48, 47, 46, 45, 44, 43, all of D.P. 2121, and by the southern boundaries of Lots 112, 111, 110, 109, 108, all of D.P. 2068, of Redmond Street, and of Lots 106, 105, 104, 103, 102; thence northerly generally by the western boundaries of said 102 and 48, all of D.P. 2068, to and across Matawhero Road, by the western boundaries of Lots 5 and 6, D.P. 4112, and Lots 2, 3, and 6, D.P. 4291, by the western boundary of Oates Street and Lots 38, 26, 25, 24, 23, 22, 21, and 20, all of D.P. 1942, to its intersection with the Moutohora-Gisborne railway; thence north-easterly across the said Moutohora-Gisborne railway to the southern boundary of part Section 9; thence easterly generally by the southern boundary of said part Section 9 to its intersection with the northern side of Cochrane Street, being the point of commencement.

BOUNDARIES OF COUNTY OF COOK

All that area in the Gisborne and Hawke's Bay Land Districts bounded as follows:

Commencing at the intersection of a road with the south-western boundary of Small Grazing Run No. 42 in Block XI, Waingaromia Survey District; thence north-westerly by that boundary to the north-eastern corner of Section 3, Block XI, Waingaromia Survey District; thence by the south-eastern boundaries of that section and of Section 1, Block XI, Waingaromia Survey District, to the middle of the Kaitangata Stream; thence by the middle of that stream, the Hinakiwahia Stream and the boundary of Section 4, Block XV, Waingaromia Survey District, to the easternmost corner of that section; thence by the southern boundary of the said Section 4, Block XV, Waingaromia Survey District, the eastern boundary of Waihora 2B 2, 2B 1A Blocks, the northern and south-western boundaries of Waihora 2B 1B Block to the northernmost corner of Papakorokoro No. 5 Block; thence by the south-eastern boundaries of Papakorokoro Nos. 6, 4A, 4B Blocks to the middle of the Mangaruaki Stream; thence by the middle of that stream, the south-eastern and south-western boundaries of Papakorokoro No. 3 Block, the eastern boundary of Papakorokoro 2A 1 Block, again to the middle of the Mangaruaki Stream; thence by the middle of that stream to the north-western corner of Ahirau 2G Block; thence by the south-western boundary of Ahirau 2F and 1A Blocks to the middle of the Mangataikohu Stream; thence by the middle of that stream to the Waipaoa River; thence by a line to and along the middle of that river to a point in line with the middle of the Pouarua Stream; thence to and by the middle of that stream to its intersection with the road at the north-eastern corner of Section 12s, Repongaere Settlement, in Block XVI, Waikohu Survey District; thence to and by the middle of that road to its intersection with the middle of the Te Puni Stream; thence by the middle of that stream to the north-eastern corner of Okahuatiu 1D 2B 1 Block; thence by the southern, south-western, and north-western boundaries of Tangihanga 1A Block; thence north-westerly by the south-western boundary of Pukepapa B Block to the

easternmost corner of Lot 2, D.P. 1562; thence by the south-eastern and south-western boundaries of that lot, the north-eastern boundary of Lot 6, D.P. 2272, the north-eastern, western, and southern boundaries of Lot 5, D.P. 2272, to the middle of a public road; thence by the middle of that road to a point opposite the northernmost corner of Section 3 (Ngatapa Settlement), Block X, Waikohu Survey District; thence to and by the north-western boundary of that section, the north-eastern boundary of Section 2 (Ngatapa Settlement), the northern and eastern boundaries of Section 5 (Ngatapa Settlement), both Block X, Waikohu Survey District, to the middle of the Patutahi-Rere Main Highway (No. 331); thence westerly by the middle of that highway to the middle of the Wharekopae Stream; thence westerly by the middle of that stream to a point opposite the easternmost corner of Lot 2, D.P. 1128; thence to and by the south-eastern boundary of that lot, the north-eastern and north-western boundaries of Hangaroa-Matawai B 4 Block, the northern boundaries of Small Grazing Runs 77 and 76, and of Lot 11, D.P. 1505, produced to the middle of the Mutuera Road; thence southerly by the middle of that road and another public road to the middle of the Hangaroa River; thence north-westerly by the middle of that river to the eastern boundary of State forest No. 91; thence southerly by the eastern boundary of that State forest to the northern boundary of Lot 23, D.P. 1952; thence easterly by the northern boundary of the said Lot 23, the northern boundary of Lot 24, D.P. 1952, southerly by the eastern boundary of the said Lot 24, D.P. 1952, to Trigonometrical Station K (Kaiaranga) being the most northerly point of Lot 21, D.P. 1951; thence south-easterly generally by the north-eastern boundaries of the said Lot 21, D.P. 1951, to the northern boundary of Section 3, Block VIII, Tuahu Survey District; thence easterly by the northern boundary of the said Section 3 and of Section 1, Block VIII, Tuahu Survey District, to the north-eastern corner of the said Section 1; thence south-westerly by the south-eastern boundary of that section to a point in the middle of the Hangaroa Junction - Waikaremoana road; thence north-easterly by the middle of that road to the Bushy Knoll Road; thence south-easterly by the north-eastern boundary of that road to the north-west corner of Section 10, Block IX, Hangaroa Survey District; thence easterly and southerly by the northern and eastern boundaries of the said Section 10 to the Bushy Knoll Road aforementioned; thence southerly generally by the eastern side of the said road to a point opposite the eastern boundary of Section 11, Block IX, Hangaroa Survey District; thence southerly across the road to and by the last-mentioned boundary and the north-western boundary of Tauwharetoi 4B Block to the northernmost corner of that block; thence south-easterly by the north-eastern boundaries of Tauwharetoi 4B and 3B 1 Blocks, the north-western boundary of Section 2, Block XIV, Hangaroa Survey District, to the middle of the Hangaroa River; thence by the middle of that river to a point in line with the eastern boundary of Mangapoike 2A No. 2 Block in Block II, Opoiti Survey District; thence southerly to and by the eastern boundary of that block to Lot 4, D.P. 1938; thence north-easterly, easterly, and south-westerly by the north-western boundary of the said Lot 4, the northern and eastern boundaries of Lot 5, D.P. 1939, to the north-western boundary of Mangapoike part 2D Block; thence north-easterly by that boundary to connecting point K, M.L. Plan 1628D; thence southerly by a right line to connecting point F4, M.L. Plan 1628D on the north-western boundary of Mangapoike 2F Block; thence north-easterly by the north-western boundary of the said Mangapoike 2F Block produced to the middle of the Mangarangiara Stream; thence south-easterly by the middle of the said Mangarangiara Stream to its junction with the Mangapoike River; thence north-easterly by the middle of the said Mangapoike River to its intersection with the western boundary of Mangapoike B Block; thence southerly generally to and by the eastern boundaries of Lots 1 and 2, D.P. 1401, to the north-west corner of Mangapahi Road; thence easterly generally along the northern side of that road to the western boundary of Nuhaka 2B 2F Block; thence north-westerly by the western boundaries of that block and of Nuhaka 2B 2A 1 Block to the north-western corner thereof; thence north-easterly by the northern boundary of that block to its intersection with the south-western boundary of S.G.R. 40; thence north-westerly by that boundary to Trigonometrical Station FX (Pukeronui); thence north-easterly by the north-western boundary of the said S.G.R. 40 to Trigonometrical Station J (Pukehoe); thence south-easterly by the north-eastern boundary of the said S.G.R. 40 to its intersection with Section 1, Block VI, Nuhaka North Survey District; thence south-westerly, easterly, and north-easterly by the north-western, southern, and south-eastern boundaries of the said Section 1, to its intersection with Maraetaha 2C Block; thence south-easterly by the northern boundary of S.G.R. 40 and of a closed road, again by the said northern boundary of S.G.R. 40 across a public road and again by the said northern boundary of S.G.R. 40 to the middle of the Pungia Stream; thence southerly by the middle of that stream and the Nuhaka River for approximately 70 chains to a point in line with the east side of a public road; thence southerly generally to and by the east side of the said public road to its intersection with the north-eastern boundary of Section 2, Block XI, Nuhaka North Survey District; thence south-easterly by the north-eastern boundary of the said Section 2 to the north-western side of the Gisborne-Wairoa via Morere State Highway No. 49; thence north-easterly by the north-western boundary of the said highway to its intersection with the north-eastern boundary of Section 4, Block XI, Nuhaka North Survey District; thence south-easterly across the Gisborne-Wairoa via Morere
