NOTICE is hereby given that the Mayor, Councillors, and Burgesses of the Borough of Otaki propose, under the provisions of the above-mentioned Acts and all other Acts, powers, and authorities enabling it in that behalf, to execute a public work, namely, housing purposes, and for the purposes of such public work the land described in the Schedule hereto is required to be taken; and notice is further given that a plan of the land so required to be taken is deposited in the Public Office of the Otaki Borough Council, Main Street, Otaki, and is there open for inspection without fee by all persons during ordinary office hours.
