PURSUANT to section 265 of the Maori Affairs Act 1953, I, Lieutenant-General Sir Charles Willoughby Moke Norrie, the Governor-General of New Zealand, hereby declare the land described in the Schedule hereto to be Crown land and to be subject to the Land Act 1948.

SCHEDULE

SOUTH AUCKLAND LAND DISTRICT

ALL that piece of land containing 365 acres, more or less, known as the Whangamata No. 6B1 Block, situated in Block VII, Ohinemuri Survey District, being all the land in certificate of title, Volume 348, folio 242, Auckland Registry, as shown on the plan numbered M.L. 3836A lodged in the office of the Chief Surveyor at Auckland.
