

*Prohibition of Access Other Than by Permit to Public Reserves*

PURSUANT to the Reserves and Domains Act 1953, the Minister of Lands hereby prohibits access, other than by permit to be issued by the Commissioner of Crown Lands for the North Auckland Land District, to the public reserves described in the Schedule hereto.

SCHEDULE

NORTH AUCKLAND LAND DISTRICT

THOSE groups of islands lying to the east of the north-eastern coast of the North Auckland peninsula, known as Little Barrier (Hauturu), the Poor Knights (Tawhiti Rahi, Aorangi, Aorangaia, and others), and the Hen and Chickens (Taranga and Moro Tiri).

Also that group of islands lying north-west of the north-western extremity of the North Auckland peninsula, known as Three Kings (Manawatawhi).
