Exemption Order Under the Motor Drivers Regulations 1940

Minister of Transport hereby orders and declares that the provisions of clause (1) of regulation 7 of the said regulations so far as they relate to the driving of heavy trade motors shall not apply to the persons hereinafter mentioned, but in lieu thereof the following provision shall apply:

A motor driver's licence issued under the Motor Drivers Regulations 1940 to the persons described in Column 1 of the Schedule hereunder may authorise them to drive a heavy trade motor in the course of their employment for the employers described in Column 2 of the said Schedule, but shall not authorise them while they are under the age of eighteen years to drive a heavy trade motor for any other purpose.

PURSUANT to section 100 of the Counties Act 1920, the Patangata County Council hereby resolves that all the land mentioned in the Schedule hereto be included into the Mangatarata Riding of the County of Patangata, and excluded from the Pourerere Riding of the County of Patangata, such special order to become effective from the 1st April 1956.
