That in accordance with the provisions of section 23 of the Counties Act 1920, the Akaroa County Council proposes to alter the boundaries of the Le Bons Bay and Wainui Ridings in order to include within the Le Bons Bay Riding the area described in the Schedule hereunder, and certified correct by the Chief Surveyor.
