ADJUSTING REPRESENTATION IN THE COUNCIL

IN exercise of the powers conferred on it by section 23 of the Counties Act 1920, the Makara County Council resolves, by way of special order, as follows:

- 1. The present division of the County of Makara into two ridings is revoked, and in lieu thereof the said County shall be divided into four ridings, to be called respectively Makara Riding, Ohariu Riding, Belmont Riding, and Porirua Riding, which said ridings are respectively described in the Schedule hereto.
- 2. The said Makara County Council shall consist of ten members, who shall be elected as follows:
 - (a) The electors of the Makara Riding, the Ohariu Riding, and the Belmont Riding shall each elect one Councillor;
 - (b) The electors of the Porirua Riding shall elect seven Councillors.
- 3. The alterations hereby made shall take effect on and after the 14th day of July 1956.
