

and along the north-western boundary of Section 11, Block XVI aforesaid, crossing an intervening public road, along the north-western boundary of Section 5, Block IV, Rotorua Survey District, crossing an intervening public road, and along a right line across another public road, to and along the north-western boundary of Section 8, Block IV aforesaid, and along a right line, being the last-mentioned boundary produced to the middle of the Mangorewa River; thence westerly and north-westerly generally up the middle of the said river, to and up the middle of the Ohaupara Stream to a point in line with the north-western boundary of Section 13, Block III, Rotorua Survey District; thence along a right line, to and along the north-western boundary of Section 13 aforesaid, to and along the north-eastern boundary of Taumata No. 3A 1B Block to its intersection with a right line between the westernmost corner of Section 9, Block V, Horohoro Survey District, and Trig. Station No. 27, Puwhenua, being the easternmost corner of Block VII, Tapapa East Survey District; thence northerly generally along the said right line to Trig. Station No. 27 aforesaid, and along another right line between the said Trig. Station No. 27 and Trig. Station No. 146, Te Werātū, being the westernmost corner of Block IV, Opoitini Survey District, to the last-mentioned trig. station; thence along another right line to Trig. Station No. 909, Waiuanu, being the easternmost corner of Block XVI, Wairere Survey District; thence along the north-eastern boundary of part of Okauia No. 1 Block to the westernmost corner of Whakamarama No. 2 Block; thence north-westerly and north-easterly generally along the boundaries of the Electoral Districts of Piako and Hauraki, hereinbefore described, to the point of commencement; and including Mayor Island, Motiti Island, and other adjacent islands.

WAIKATO

All that area bounded by a line commencing at a point in Block XII, Puniu Survey District, in the middle of the Puniu River, in line with the middle of Andrew Road; thence northerly, easterly, and south-easterly generally along the boundaries of the Electoral Districts of Waipa, Piako, and Tauranga, hereinbefore described, to the intersection of the north-eastern boundary of the Taumata No. 3A 1B Block in Block II, Rotorua Survey District, and the right line from Trig. Station No. 27, Puwhenua, to the westernmost corner of Section 9, Block V, Horohoro Survey District; thence southerly generally along that right line to and along the south-western boundary of Section 9 aforesaid to its southernmost corner; thence along a right line, to and along the south-western boundary of Patere South No. 1B 3 Block, to and along the generally western boundaries of part of Lots 11 and 10, D.P. 12325, being parts of the Tikorangi and Whakamaru-Maungaiti Blocks, along the western boundaries of Lots 2 and 1, D.P. 20272, being parts of the aforesaid Whakamaru-Maungaiti Block and Sections 3 and 4, Block III, Te Atiamuri Survey District, and along a right line, being the last-mentioned boundary produced, across the Rotorua-Atiamuri Main Highway to its southern side; thence easterly along the southern side of that main highway to the middle of the stream forming part of the eastern boundary of Lot 2, D.P. 15486, being part of the Whakamaru-Maungaiti Block aforesaid; thence southerly generally down the middle of that stream to and down the middle of the Whangapoa Stream to its confluence with the Waikato River; thence north-westerly generally down the middle of the said river and the middle of Arapuni Lake to a point in line with the northern boundary of Section 10, Block IV, Wharepapa Survey District; thence south-westerly generally along a right line to and along that northern boundary, along another right line through part Section 1 of the said Block IV and across a public road, to and along the northern boundaries of Sections 8 and 7, Block III, Wharepapa Survey District, along a right line across a public road, to and along the northern boundaries of part Wharepuhunga No. 16B 3B 3D 2 Block and of Wharepuhunga No. 16B 2 Block, and along another right line across a public road, to and along the northern and north-western boundaries of part Wharepuhunga No. 16B 3B 3E Block, and the north-western boundaries of Wharepuhunga Nos. 16B 3B 3B and 16B 3B 3A Blocks, and Section 9, Block VI, Wharepapa Survey District, to Trig. Station 1593, Whatauri; thence north-westerly generally along the north-eastern boundaries of Lots 2 and 1 on D.P. 37228, being parts of Section 13 of the said Block VI, along the north-eastern boundaries of Sections 6 and 1 of Block II, Wharepapa Survey District, along the north-eastern boundary of Lot 1 on D.P. S. 891, being part of Section 1, Block I, Wharepapa Survey District, along a right line to and along the north-eastern boundary of Lot 2 on D.P. 27307, being part of the last-mentioned Section 1, and along another right line, being that north-eastern boundary produced to the middle of the Puniu River; thence down the middle of that river to the point of commencement.

ROTORUA

All that area bounded by a line commencing at a point in Block XVI, Wharepapa Survey District, being the confluence of the Waikato River and the Waipapa Stream; thence easterly, northerly, and again easterly generally along the boundaries of the Electoral Districts of Waikato and Tauranga, hereinbefore described, to a point in the middle of the Mangorewa River in line with the north-western boundary of Section 8, Block IV, Rotorua Survey District; thence easterly generally down the middle of the said river to a point in line with northern boundary of Section 9, Block I, Rotoiti Survey District; thence along a right line to and along the said northern boundary, the abutment of Kapukapu Road, the northern boundaries of Sections 1 and 2, Block II, Rotoiti Survey District, the northern boundary of Ngaipahiko B No. 1B Block and its production to the middle of the Kaituna River; thence up the middle of that river to a point in line with the north-eastern boundary of Okere No. 1E Block, along a right line to and along that north-eastern boundary and its production to the middle of the Te Ngae - Paengaroa Main Highway; thence southerly along the middle of the said main highway to a point in line with the northern boundary of part Waiapapa No. 1B Block; thence to and along that northern boundary and its production to and up the middle of the Pokopoko Stream to a point in line with the northern boundary of Rotoiti 3V Block; thence easterly generally along a right line to and along the northern boundaries of the said 3V Block and Rotoiti Nos. part 4, 5A, and 5B Blocks, crossing the intervening Maniatutu and Kaikokopu Roads, and the Pongakawa Stream to a point in line with the northern boundary of Section 2, Block I, Rotoma Survey District, along a right line to and along the said northern boundary and its production to the middle of the Pongakawa-Rotoehu Road; thence south-easterly generally along the middle of that road to a point in line with the northern boundary of Section 18, Block VI, Rotoma Survey District; thence easterly along a right line to and along the northern boundaries of the said Section 18 and Section 15, Block VI aforesaid, and Section 8,
