

PATEA

All that area bounded by a line commencing at a point in the middle of the mouth of the Manawapou River in Block XIV, Hawera Survey District; thence north-easterly and easterly generally along the boundaries of the Electoral Districts of Egmont, Stratford, and Waitomo, hereinbefore described, to Trig. Station No. 28, Manukaipū, situated in Block XVI, Kaimanawa Survey District; thence southerly along a right line to Trig. Station No. 24, Te Rotete, a right line to Trig. Station C, Auahitotara, a right line to Trig. Station No. 16, Kauaeke, Block XV, Moawhango Survey District; and a right line to Trig. Station No. 32, Papakai, situated in Section 6, Block XV, Ohnewairua Survey District; thence westerly generally along a right line to the junction of Panemango and Tamokomoko Streams, Block XV, Maungakaretu Survey District; thence westerly along the southern boundaries of Ruanui No. 2, 2b No. 3, 2b No. 4, 2b No. 5, 2b No. 6 and 2b No. 7 Blocks and the south-western boundary of Section 1, Block X, Maungakaretu Survey District, to survey mark Rereamaru, being a point on the said south-western boundary; thence north-westerly along a right line to Trig. Station R (Maungakaretu), Block IX, Maungakaretu Survey District; thence south-westerly generally along right lines from hill to hill along the summit of the eastern watershed of the Whangaehu River to the north-eastern corner of Forest Reserve, Section 6, Block XII, Mangawhero Survey District; thence along the eastern boundary of that reserve to and along the north-eastern boundary of the Ohaunoko Block and its production to the middle of the Turakina River; thence down the middle of that river to a point in line with the western boundary of Section 96, Parekaretu Block; thence to and along that boundary and the south-eastern boundary of that section to the northern corner of Section 98, Parekaretu Block; thence along that road to and its production to the middle of Lochaber Road, and along that road to a point in line with the western boundary of Section 63; thence to and along that boundary, the western boundary of Section 62 and its production to the middle of Maungahoe Road, and along that road to a point in line with the eastern boundary of Section 60; thence to and along that boundary and the eastern boundary of Section 58 and its production to the middle of Mount Curl Road; thence south-westerly along the middle of that road to a point in line with the south-western boundary of Section 16, Parekaretu District, situated in Block VIII, Whangaehu Survey District; thence north-westerly along that boundary to the northernmost corner of Section CCLXXIII, Rangitikei Blocks District; thence along the north-western boundary of that section to and along the north-eastern boundary of Section LXXII, the north-eastern and north-western boundaries of Section LXI, across a public road, and along the north-eastern and north-western boundaries of Sections CCII, CCIX, and CCX, the south-eastern and south-western boundaries generally of Sections CCLXXXV and CCLXXVI, all of Rangitikei Blocks District, to the eastern boundary of Section 77, Turakina District; thence southerly along the eastern boundaries of that section and Sections 69, 68, 66, 62, and 54, all of Turakina District, to the north-western corner of Section 23, Block I, Rangitoto Survey District; thence easterly along the northern boundaries of that section, and Section 24, Block I aforesaid, and its production to the middle of Williamson Road; thence south-easterly generally along the middle of that road, Makirikiri Road, Crofton Cross Road, and Cliff Road, to a point in line with the northern boundary of Section VA, Block VII, Rangitoto Survey District; thence along a right line to and along the said northern boundary and its production to and down the middle of the Rangitikei River to the sea; thence north-westerly generally along the sea coast to the point of commencement; and excluding the Electoral District of Wanganui, hereinafter described.

WANGANUI

All that area bounded by a line commencing at the south-western corner of Lot 7A, D.P. 2139; thence north-easterly generally along the western boundaries of that lot and Lots 7, 5A, and 5 as shown on the D.P. 2139 aforesaid to and along the western boundary of Lot 3 as shown on that plan to the north-western corner of that lot, along a right line to the south-western corner of Lot 7 as shown on D.P. 2006, along the western boundary of that lot to Fox Road; thence south-easterly along the south-western side of Fox Road to a point in line with the middle of Oxford Road; thence north-easterly to and along the middle of that road to a point in line with the south-western boundary of Lot 5 as shown on the D.P. 9673; thence south-easterly to and along that boundary and north-easterly along the south-eastern boundary of Lot 5 aforesaid to the south-western boundary of Lot 19 as shown on D.P. 9673 aforesaid; thence south-easterly along that boundary and the south-western boundaries of Lots 18, 17, 16, and 15 as shown on D.P. 9673 aforesaid and Lots 59, 60, 61, 62, 63, 64, 65, 66, 67, and 68, Block II, as shown on D.P. 4484; thence north-easterly along the south-eastern boundary of Lot 68 aforesaid and its production to the middle of Surrey Road; thence south-easterly along the middle of that road to a point in line with the south-eastern boundary of Lot 6 as shown on D.P. 8032; thence north-easterly to and along that boundary and the south-eastern boundaries of Lot 2 as shown on D.P. 18584, Lot 32, Block IV, as shown on D.P. 4484 aforesaid, and the production of the last-mentioned boundary to the middle of Devon Road; thence south-easterly along the middle of that road to a point in line with the south-eastern boundary of Part Lot 13 as shown on D.P. 5965; thence north-easterly to and along that boundary and its production to Jones Avenue, across Jones Avenue to and along the south-eastern and north-eastern boundaries of that part of Lot 1 as shown on Deeds Plan 440, comprised and described in certificate of title, Volume 390, folio 294, Wellington Registry, to a point in line with the north-western boundary of that part of Lot 2, as shown on the aforesaid Deeds Plan 440, comprised and described in certificate of title, Volume 515, folio 195, to and along that boundary and the north-eastern boundary of that land for a distance of 21.95 links, along a right line to the north-eastern boundary of Lot 3 as shown on the aforesaid Deeds Plan 440 at a point 264 links from Parsons Street, south-easterly along that boundary to a point in line with the south-eastern boundary of Lot 6 as shown on the aforesaid Deeds Plan 440, to and along that boundary, across the Springvale-Francis Main Highway to and along the south-eastern boundary of Lot 6 as shown on D.P. 6429, along a right line to and along the north-western boundaries of Lots 12, 13, and 14 as shown on D.P. 6429 aforesaid, to and along the north-western boundaries of Lots 15, 16, 17, and 18 as shown on D.P. 6429 aforesaid, along the production of the last-mentioned boundary to the south-western boundary of Lot 7 as shown on D.P. 12936; thence north-westerly along the south-western boundaries of Lot 7 aforesaid and Lots 6, 5, 4, 3, 2, and 1 as shown on D.P. 12936 aforesaid; thence north-easterly along the north-western boundaries of Lot 1 aforesaid, and Lots 7 and 3 as shown on D.P. 3489, to the eastern corner of Lot 1 as shown on D.P. 768; thence north-westerly and north-easterly generally along the north-eastern boundaries of the said Lot 1 to Peakes Road;
