

on D.P. 8235; thence westerly along the southern boundaries of the said Lot 9 and Lot 8 on the said plan to the south-western corner of the last-mentioned Lot 8; thence generally northerly along the western boundaries of the said Lot 8, Lots 2 and 1 on D.P. 2819, and part Lot 31 on D.P. 3002, to the south-eastern corner of Lot 1 on D.P. 6771; thence south-westerly along the south-eastern boundaries of Lots 1, 2, and 3, a right line to the south-eastern corner of Lot 4, and along the south-eastern boundaries of Lots 4, 5, 6, 7, 8, 9, and 10, all on D.P. 6771, to the south-western corner of the last-mentioned Lot 10; thence generally north-westerly along the south-western boundary of the said Lot 10 to and across Iona Road and along the south-western boundaries of Lots 7 and 3, Reynolds Road, and Lot 1, all on D.P. 3002, to the north-western corner of the last-mentioned Lot 1; thence north-easterly along the north-western boundaries of Lots 1 and 2 on D.P. 3002, a right line across Breadalbane Road, along the north-western boundaries of Lot 1 on D.P. 3402, Lot 1 on D.P. 4237, part Lots 13 and 14 on the aforementioned D.P. 3002, Part Lot 1 on D.P. 4223, and Lot 1 on D.P. 4437, and the production of the last-mentioned boundary to the middle of the Herehere Stream; thence north-westerly generally along the middle of that stream to the old bed of the Ngaruroro River; thence westerly along the middle of the old bed of the said river to a point in line with the middle of a road forming the south-western boundary of Section 8, Pukahu Agricultural Sections; thence southerly along a straight line to and along the middle of that road to Te Aute Road; thence north-westerly generally along the middle of Te Aute Road, Longlands Road, the Farndon-Fakipaki Main Highway, and Irongate Road, and north-easterly generally along the middle of Wilson Road, Omahu Road, and Raupare Road to and along the north-western boundary of the land on D.P. 3659 and its production to the middle of the Ngaruroro River; thence south-easterly and north-easterly generally along the boundary of the Electoral District of Napier, hereinbefore described, to the sea; thence southerly along the sea coast to the point of commencement.

MANAWATU

All that area bounded by a line commencing at a point in the middle of the mouth of the Rangitikei River; thence north-easterly and southerly generally along the boundaries of the Electoral Districts of Patea, Rangitikei, and Hawke's Bay, hereinbefore described, to a point on the summit of the Ruahine Range due west of the source of the Makaretu River; thence south-westerly along the summit of the Ruahine Range to Trig. Station Wharite; thence westerly generally along the north-eastern boundary of Section 6, Block VII, Gorge Survey District, the north-western boundaries of the said Section 6, and Sections 1, 3, and 4, Block VII aforesaid, and Section 6, Block II, Gorge Survey District, the eastern, northern, and western boundaries of Section 2, Block II aforesaid, and the production of the last-mentioned boundary to the middle of the road forming the south-western boundary of Section 1, Block II aforesaid; thence westerly along the middle of that road to the south-eastern boundary of the Manchester Block Registration District; thence south-westerly along that boundary and its production to and up the middle of the Manawatu River to a point in line with the western boundary of Section 1, Block I, Mangahao Survey District; thence to and along the western boundary of Section 1 aforesaid and its production to the eastern side of Range Road North; thence in a general south-westerly direction along the eastern side of Range Road North to its intersection with the south-western boundary of part Subdivision 3 of Section 26, Block II, Mangahao Survey District; thence along the south-western boundary of Subdivision 3 of Section 26 to the northernmost corner of Section 2, Block II, Mangahao Survey District; thence along the eastern side of the road forming the north-western boundaries of Sections 2 and 10, Block II, Mangahao Survey District, to and along Range Road North, across the Palmerston North - Pahiatua road, and along the eastern side of Range Road South to the south-western corner of Section 13, Block XIX, Mangahao Survey District; thence along the south-western boundary of Section 13 aforesaid, the north-western boundaries of Sections 1, 2, 3, Block VI, and Section 4, Block V, Mangahao Survey District, and the abutment of Marima Ridge Road to the north-western corner of Section 9, Block IX, Mangahao Survey District; thence along a right line to Marima Trig. Station; thence along a right line to Araruru Trig. Station; thence along a right line in the direction of Trig. Station Mount Dundas in Block XI, Tararua Survey District, to its intersection with another right line bearing 295° 30' magnetic, as described in the Schedule of the Eketahuna County Act 1898, from a point in the middle of the Makakahi River in line with the western boundary of Section 21, Block XIV, Tararua Survey District; thence north-westerly generally along a right line to the intersection of the summit of the Tararua Range with the northern boundary of Section 2, Block IV, Waiopehu Survey District; thence along the Tararua Range aforesaid to the southern boundary of Section 3, Block IV, Waiopehu Survey District; thence along the southern boundary of the said Section 3 to a point in line with the southern boundary of Section 12, Block XV, Mount Robinson Survey District; thence across a road and along the southern boundaries of Section 12 aforesaid and Sections 13 and 20, Block XV aforesaid, and the southern boundary of the last-mentioned section produced to the middle of a road; thence along the middle of that road to a point in line with the southern boundary of Section 4, Block XV aforesaid; thence to and along the southern boundary of that section, the southern boundary of Section 3, Block XV aforesaid, the abutment of a road, the southern boundaries of Sections 2 and 1, Block XV aforesaid, the southern boundary of Section 3, Block X, Mount Robinson Survey District, and a right line across the North Island Main Trunk Railway to the southernmost corner of Section 2, Block X aforesaid; thence along the western boundaries of Sections 2 and 1, Block X aforesaid, and the production of the last-mentioned boundary to the middle of the Manawatu River; thence down the middle of that river to the sea; thence northerly along the sea coast to the point of commencement; and excluding the Electoral District of Palmerston North, hereinafter described.

PALMERSTON NORTH

All that area bounded by a line commencing at a point in the middle of the Manawatu River in line with the middle of Maxwells Line; thence north-westerly and north-easterly along a right line to and along the middle of Maxwells Line and the Palmerston North - Himatangi State Highway to a point in line with the north-eastern boundary of Rural Section 350, Township of Palmerston North; thence north-westerly along a right line to and along the north-eastern boundary of the said Section 350 to the westernmost corner of Section 290, Township of Palmerston North; thence along the north-western and north-eastern boundaries of the said Section 290 to a point in line with the middle of Featherstone Street
