

parish, to the northern corner of the last-mentioned lot; thence south-westerly generally along the south-eastern boundaries of Allotments 198, N.E. 155, S.W. 155, N.E. 156, S.W. 156, N.E. 157, S.W. 157, S.E. 159, 68, M. 67, S.W. 67, N.E. 66, S.W. 66, N.E. 65, M. 65, S.W. 65, part N.E. 61, along a right line across the North Auckland Main Trunk Railway, to and along the south-eastern boundaries of Allotments part M. 61, S.W. 61, 59, and S.E. 1, all the aforesaid allotments being of Waikiekie Parish, along the south-eastern boundaries of Allotments 63, S.E. 51, 44, 162, all of Tauraroa Parish, and along a right line, being the last-mentioned boundary produced to the middle of the Mangonui River; thence north-westerly generally up the middle of the said river to and along the boundary of the Electoral District of Hobson, hereinbefore described, to the sea coast; thence southerly generally along the sea coast, crossing the mouths of all harbours and inlets, to the point of commencement; and including the Poor Knights Islands, the Hen and Chickens Islands, Mokohinau Island, and other adjacent islands.

RODNEY

All that area bounded by a line commencing at a point on the sea coast at Bream Tail in Block I, Mangawhai Survey District, in line with the north-western boundary of Allotment 309, Waipu Parish, and proceeding southerly generally along the sea coast, crossing the mouths of all harbours and inlets, to a point in the middle of the mouth of the Waivera River; thence westerly up the middle of that river to a point in line with the northern boundary of Waivera Parish; thence to and along that boundary and southerly along the western boundary of that parish to the south-western corner of Allotment 34, Waivera Parish; thence along the northern boundary of Allotment 29, Kapakapa Parish, the northern and western boundaries of Allotment 52, the western boundaries of Allotments 57, 58, and 63 to a point in line with the north-western boundary of Allotment 65, across a public road, to and along that boundary and the north-eastern and eastern boundaries of Allotment 64, all the aforesaid allotments being of Kaupakapa Parish, to the easternmost corner of the said Allotment 64; thence along a right line to the confluence of the Waitoki and Waipapakara Streams; thence up the middle of the Waipapakara Stream to the north-eastern corner of Allotment 306, Pukeatua Parish; thence along the generally eastern boundary of the aforesaid Allotment 306 to a point in line with the south-western boundary of part Allotment S. 23, Pukeatua Parish; thence along a right line across a public road to and along the south-western boundary of part Allotment S. 23 aforesaid, the north-western and south-western boundaries of Allotment 24, the south-western boundaries of Allotments 25, 26, 27, and 28, the southern boundary of Allotment 28 aforesaid, and the southern boundary of Allotment E. 29 to a point due north of the north-eastern corner of Allotment 39, the aforesaid allotments being of Pukeatua Parish; thence along a right line across a public road to and along the south-eastern boundary of Allotment 39 aforesaid and the south-eastern boundary of Allotment 38 and its production to the middle of Bald Hill Road, all the aforesaid allotments being of Pukeatua Parish; thence southerly generally along the middle of Bald Hill Road to a point due north of the northern corner of a closed road through Section 25, Riverhead Homestead Settlement; thence along a right line to and along the western boundary of the said closed road and the south-eastern boundary of the said Section 25 to a point due north of the north-western corner of Section 31H, Riverhead Homestead Settlement; thence along a right line to and along the western boundary and south-western boundaries of the said Section 31H and the south-western corner of the last-mentioned section; thence along a right line to the northernmost corner of Allotment 39, Ararimu Parish; thence along the northern boundary of the said Allotment 39 to and along the eastern boundary of a closed road through the said allotment, the western boundary of Section 38H, Riverhead Homestead Settlement, the generally western boundaries of Allotments 462, 460, and 105, Paremoremo Parish, the western boundaries of Sections 43H, 44H, and 51H, Riverhead Homestead Settlement, and a right line due south to the middle of the road forming the northern and western boundaries of Allotment 222, Paremoremo Parish; thence southerly generally along the middle of that road to a point in line with the south-eastern boundary of Allotment 222 aforesaid; thence to and along that boundary and the south-western boundary of Allotment 221, Paremoremo Parish, and the production of the last-mentioned boundary to the middle of the Rangitopuni Stream; thence down the middle of that stream to and along the western shore of Waitemata Harbour to the middle of the mouth of Henderson Creek; thence up the middle of Henderson Creek to and up the middle of Huruhuru Creek to Don Bucks Road; thence south-easterly along the middle of a public road to Ranui Road; thence southerly generally along the middle of Ranui Road, Metcalf Road, Hetherington Road, and Candia Road to Henderson Valley Road; thence easterly along the middle of Henderson Valley Road and south-easterly along Parr's Cross Road to the Waikomete - West Coast Main Highway; thence easterly along the middle of that highway to a point in line with the eastern boundary of Lot 4, Deeds Plan 269; thence southerly generally to and along the eastern boundary of Lot 4 aforesaid, to and along the northern and eastern boundaries of Allotment 114, Waikomiti Parish, and the production of the last-mentioned boundary to the middle of View Road; thence westerly along the middle of View Road to and southerly along the eastern boundary of Lot 4 of Allotment 15 of the said parish, and the eastern boundaries of Lots 3, 2, and 1 of Allotment 15 aforesaid, the land shown on D.P. 2773 and Lot 1, D.P. 23309, to the south-eastern corner of the last-mentioned lot; thence westerly along the southern boundary of that lot and its production to the middle of Shaw Road; thence southerly along the middle of that road crossing the Waitakere Scenic Drive to a point in line with the southern boundary of Lot 27, D.P. 37552; thence to and along the southern boundaries of the said Lot 27 and Lots 26, 25, 24, 23, 22, 21, 20, 19, 18, 17, 16, 15, 14 and the eastern and southern boundaries of Lot 13, the aforesaid lots as shown on the said D.P. 37552, and being part Allotment 17, Waikomiti Parish; thence along the western boundary of Allotment 30 to and along the northern boundary of Allotment 31 and its production to the middle of Exhibition Drive, the aforesaid Allotments being of Waikomiti Parish; thence southerly along the middle of Exhibition Drive to New Lynn - Huia Main Highway and south-westerly along the middle of the said highway to the Nihotupu Stream; thence down the middle of that stream to Manukau Harbour; thence south-westerly generally along the shore of Manukau Harbour and north-westerly along the sea coast to the middle of the mouth of Kaipara Harbour; thence northerly generally along the eastern boundary of the Electoral District of Hobson, hereinbefore described, to the middle of the Mangonui River; thence easterly generally along the southern boundary of the Electoral District of Marsden, hereinbefore described, to the point of commencement; and including Little Barrier Island, Kawau and Motuketekete Islands, and other adjacent islands.
