

of Allotment 269 of Section 2 aforesaid to a point in line with the north-western boundary of that allotment, across the road, along the south-eastern and eastern boundaries of Allotment 264, the southern boundary of Allotment 244, and the southern and western boundaries of Allotment 245 to the northernmost corner of that allotment, across a road, and along the northern side of the road forming the south-western boundary of Allotment 61, Section 2 aforesaid, to Allotment 65; along the south-eastern and north-eastern boundaries of that allotment, the north-eastern boundary of Allotment 66 and across a road, along the north-western side of that road to the easternmost corner of Allotment 68, along the north-eastern boundaries of Allotments 68 and 69, across a road and along its north-western side to the easternmost corner of Allotment 76, along the north-eastern boundary of that allotment, across a road and along its north-western side to the south-eastern corner of Allotment 93, along the north-eastern boundary of that allotment to the middle of Belmont Road; thence south-westerly generally along the middle of that road, the public road forming the south-western boundary of Allotment 102, and the public road forming the north-western boundary of Allotments 157, 158, 159, 160, 161, 167, 168, 169, and 170, all the aforementioned allotments being of Suburban Section 2, Parish of Pukekohe, and the production of the last-mentioned middle line across another public road to the north-eastern boundary of Allotment 32, Parish of Puni; thence along that boundary to and along the north-western boundary of Allotment 33, the north-eastern boundary of Allotment 35, the north-western boundaries of Allotments 35 and 37, the north-eastern and north-western boundaries of Allotment 40, the north-western boundary of Allotment 41, the north-eastern boundaries of Allotments 43 and 42, and the north-western boundary of the last-mentioned allotment to the Waiuku-Pukekohe Main Highway; thence along a right line across that highway to and along the north-western boundary of Allotment 1 and the north-eastern and north-western boundaries of Allotment 2 to the westernmost corner of the last-mentioned allotment, all the aforementioned allotments being of the Parish of Puni; thence easterly and southerly generally along the south-western and south-eastern boundaries of Allotment 2 aforesaid, to and along the south-western boundaries of part Lot 5, Deeds Plan Whau 23, and Lot 1, D.P. 20751, both being parts of Allotment 1 aforesaid, to and along the south-eastern boundary of Section 2, Block II, Onewhero Survey District, and its production to and along the south-eastern side of the public road forming the north-western boundaries of Allotments 118 and 119, Parish of Puni aforementioned, the north-western boundary of Lot 1, D.P. 16679, being part Purapura No. 1 Block, the north-western and western boundaries of Lot 8, and the western boundaries of Lot 7, parts Lot 6, Lots 5 and 4, and parts Lot 3, the said lots being shown on Deeds Plan Whau 57 and being parts of Purapura No. 1 Block aforesaid, to and along the western and south-western boundaries of part Lot 1, D.P. 2127, being part of the aforesaid Purapura No. 1 Block, along the south-western boundary of the part Purapura No. 1 Block aforesaid shown on D.P. 3753, and along a right line, being that last-mentioned boundary produced to the left bank of the Waikato River; thence south-westerly generally down the said left bank to the sea coast; thence north-westerly along the sea coast to the point of commencement.

All that area bounded by a line commencing at the point where left bank of the Waikato River meets the sea coast; thence north-easterly generally along the boundary of the Electoral District of Franklin, hereinbefore described, to the middle of the mouth of the Puwhenua Stream; thence southerly generally along the shore of the Firth of Thames to and up the left bank of the Miranda Stream to a point in line with the north-western boundary of Lot 2, D.P. 28111, being part of Waitakaruru No. 3c 1 Block; thence along a right line across the said Miranda Stream, to and along the north-western boundary of the said Lot 2, a right line across a public road, to and along the north-western boundary of Lot 1, D.P. 28111 aforesaid, along part of the north-western boundary of Waitakaruru No. 4c 5 Block, the north-western boundary of Waitakaruru No. 4c 3 Block, another part of the north-western boundary of the said No. 4c 5 Block, and the north-western boundaries of Waitakaruru No. 4c 4 Block, and Lot 3, D.P. 21822, being part of Waitakaruru No. 4 Block, to the western corner of that lot; thence along a right line, being the production of the last-mentioned boundary, across Sections 8 and 10, Block VIII, Wharekawa Survey District, to and along the north-eastern boundary of Section 1, the north-eastern, eastern, and south-eastern boundaries of Section 2, both sections being of Block VIII aforesaid, and along the northern boundary of Section 5, Block II, Piako Survey District, to its intersection with a right line between Trig. Station 135 (Rataroa) and the north-western corner of Section 28, Block VII, Piako Survey District; thence along the said right line, to and along the south-western boundaries of the said Section 28, parts Sections 4 and 5 of the said Block VII, part Section 12 of Block XI, Piako Survey District, and Lot 2 of the said Section 12, along the abutment of a public road, another part of the south-western boundary of the said Section 12, the abutment of another public road, and a further part of the south-western boundary of the said Section 12, and the south-western boundary of Section 5 of Block XI aforesaid, along the western boundaries generally of part Sections 1 and 2, both of Block XV, Piako Survey District, a right line across a public road, to and along the western boundary generally of Section 9, Block XVI, Piako Survey District, to and along the north-western boundaries of Sections 1s and 3s, Tainui Settlement, the north-western and south-western boundaries of Hoe-o-Tainui North No. 6B 2j 1 Block, along the south-western boundaries of Hoe-o-Tainui North No. 5B 2' Block, Sections 6 and 7 of Block VIII, Hapuakohe Survey District, Hoe-o-Tainui North 5A North 2A 2, 5A North 2A 1, and 5A North 2B Blocks, and Lot 6, D.P. 13199, being part of Hoe-o-Tainui North No. 5A South 2 Block, Lot 8, as shown on the said plan numbered 13199, being part of Section 1, Block XII, Hapuakohe Survey District, Hoe-o-Tainui South No. 4A Block, Sections 18, 17, 16, and 15 of Block XII aforesaid, along the south-western boundaries of Hoe-o-Tainui South No. 1A 2 and 1A 1 Blocks, Lots 1 and 2, D.P. 29197, Lot 1, D.P. 8138, part of Lot 6, D.P. 11661, Lots 1 and 2, D.P. 12366, and Lot 1, D.P. 13235, to the south-western corner of the last-mentioned lot; thence south-westerly generally along the northern boundaries of Lots 10, 5, 4, 3, and 2, D.P. 5548A, and the northern boundaries of Lots 5, 4, 3, 2, 6, and 1, D.P. 6454A, the southern boundary of part Lot 1, D.P. 4829A, and the southern boundary of Allotment 220, Parish of Komakorau, to and across a public road to the eastern boundary of Allotment 151 of aforesaid parish; thence along the north-eastern boundaries of last-said allotment and part Allotment 230, aforesaid parish, shown on D.P. 2383A, to the south-eastern corner of Lot 9, D.P. 5383A; thence along the southern boundary of last-said lot to and across a public road to the eastern boundary of Lot 5, D.P. 8883; thence along
