Station 141, Maungahaumi; thence along the north-western boundary of Lot 8 to its westernmost corner, all the aforementioned lots being of Mangatu No. 1 Block aforesaid; thence southerly along the western boundary of Mangatu No. 3 Block, to and down the Rangiriri Stream to a point in line with the south-eastern boundary of Section 2, Block XII, Motu Survey District; thence along that boundary and its production to the middle of the Motu Front Road; thence south-easterly along the middle of that road to a point in line with the south-eastern boundary of Section 4, Block XII aforesaid; thence to and along that boundary, the south-eastern boundary of Section 2, Block XI, Motu Survey District, the eastern and south-eastern boundaries of Section 6, Block XI aforesaid, and the production of the last-mentioned boundary to the middle of Mill Road; thence northerly generally along the middle of that road to a point in line with the north-western boundary of Section 12, Block XI aforesaid; thence to and along that boundary, the north-western boundary of Section 1, Block XIV, Motu Survey District, the north-western and south-western boundaries of Section 2, Block XIV aforesaid, to the northernmost corner of Section 1, Block II, Ngatapa Survey District; thence along the western boundaries of that section, the northern and north-western boundaries of Section 3, Forest Reserve, Block II aforesaid, and the production of the last-mentioned boundary to the middle of the Koranga Stream; thence down the middle of that stream to a point in line with the north-western boundary of Section 6, Tahora No. 2c 3 Section 2 Block; thence to and along the north-western and south-western boundaries of the said Section 6 to the northern boundary of Section 12, Tahora No. 2c 1 Section 3 Block; thence along the northern boundary of the said Section 12 to the westernmost corner of that section; thence along a right line to Trig. Station Te Wana on the western boundary of Tahora Block in Block VI, Koranga Survey District; thence southerly along that boundary to its intersection with a right line running from Maungatapere Trig. Station in Block II, Ngatapa Survey District, to Trig. Station 2126, Maungapohatu, in Block XII, Ruatahuna Survey District; thence along that right line to Trig. Station 2126 aforesaid; thence along a right line in the direction of Puketapu Trig. Station in Block VII, Tuahu Survey District, to a point in line with the north-western boundary of the Waipaoa Block; thence south-westerly along a right line, to and along the said north-western boundary, the north-western boundary of a forest reserve, and the western boundary of that forest reserve to its intersection with a right line running between Puketapu Trig. Station aforesaid and the most northern point of Lake Waikaremoana; thence south-westerly along the last-mentioned line to the said northern point of Lake Waikaremoana; thence along a right line passing through a point in Block X, Tuwatawata Survey District, 180 chains due north of Maungataniwha Trig. Station, to the intersection of the said line by a right line running from Trig. Station 69, Tataraka, in Block VIII, Tarawera Survey District (Hawke's Bay Land District), to Trig. Station 76A, Tawhiuau, in Block XIV, Galatea Survey District; thence along a right line to Te Taumutu Trig. Station in Block XVI, Heruwi Survey District, and another right line to Trig. Station Pukeroa in Block XI, Heruwi Survey District; thence northerly, westerly, and again northerly generally along the boundaries of the Electoral Districts of Rotorua and Tauranga, hereinbefore described, to the point of commencement; and including all adjacent islands.

WAITOMO

All that area bounded by a line commencing at the point where the southern shore of Aotea Harbour meets the sea coast; thence easterly, southerly, and again easterly generally along the boundaries of the Electoral Districts of Waipa, Waikato, and Rotorua, hereinbefore described, to the easternmost corner of Tauhara South A Block in Block VI, Maruanui Survey District; thence southerly generally along the south-eastern boundary of the said South A Block, the eastern boundaries of Kaimanawa No. 1B and part No. 1A Blocks and the production of the last-mentioned boundary to the middle of the Mohaka River; thence south-westerly up the middle of that river and the Oamaru Stream to and along the south-eastern boundary of part Kaimanawa No. 1A Block aforesaid and its production to the middle of the Ngaruroro River; thence south-easterly generally down the middle of that river to a point on a right line between Trig. Station No. 65A and Trig. Station No. 26, Tawhaketewhango; thence westerly along that line to the said Trig. Station No. 26, along a right line to Trig. Station No. 27, Motumatai, along a right line to Trig. Station No. 28, Manukaiapu, and along another right line to Trig. Station Ruapehu, situated in Block XI, Ruapehu Survey District; thence northerly generally along a right line to Trig. Station H, Paretaitonga, situated in Block XI aforesaid; thence westerly generally along a right line to Trig. Station Te Kahatu; along another right line to the source of the Makatote Stream, and down the middle of that stream to the eastern boundary line of Section 13, Block VIII, Manganui Survey District; thence along a right line running due south to the middle of the Manganui-a-te-Ao River; thence down the middle of that river to a point in line with the south-western boundary of Section 24, Block XI, Manganui Survey District; thence to and along the south-western boundary of that section and its production to the middle of the Raetihi-Waimarino road, along the middle of that road to a point in line with south-western boundary of Section 24, Block VII, Manganui Survey District; thence to and along the south-western boundary of that section, part of the south-eastern boundary of Section 4, Block VI, to its southernmost corner, and along its south-western boundary to and along the middle of Makino Road, to a point in line with the south-western boundary of Section 2, said Block VI; thence to and along that boundary and the south-western boundaries of Section 1, Block VI, and Section 4, Block II, part of the north-western boundary of the last-mentioned section, and the south-western boundary of Section 3, Block I, Manganui Survey District, and that boundary produced to the middle of the Ruatiti-Erua road, and along the middle of that road to a point near the south-western corner of Section 3, Block II, Manganui Survey District; thence to and along the western boundary of that section and part of the southern boundary of Section 8, Block XIII, Kaitieke Survey District, to the Kokako Road, to and along the middle of that road to a point in line with the south-western boundary of Section 5, said Block XIII; thence to and along the south-western boundaries of Sections 5 and 3, and the north-western boundary of Section 4, Block XIII aforesaid, and its production to the middle of the Maungaroa Road, along the middle of that road to the northernmost corner of Section 3, Block IV, Whirinaki Survey District; thence along the northern boundaries of Blocks IV, III, II, and I, Whirinaki Survey District aforesaid, to the middle of the Wanganui River; thence up the middle of that river to a point in line with the south-western boundary of Koiro No. 3 Block; thence north-westerly along a right line to and along the south-western boundaries of Koiro Nos. 3, 4E, and 5 Blocks to the south-western corner of the last-mentioned block; thence northerly along the western boundary of that block
