

to its north-western corner; thence easterly generally along the northern boundaries of Koiro Nos. 5 and 4A Blocks to the western boundary of Section 1, Block III, Heao Survey District; thence along the western boundary of Section 1 aforesaid, to a point in line with the southern boundary of part K No. 1, Section 2c No. 4 Ohura South Block in Block XV, Ohura Survey District; thence to and along that boundary and northerly along the western boundary of the said block and its production to the middle of the Ohura River; thence up the middle of the Ohura River to a point in line with the western boundary of Section 7, Block XI, Ohura Survey District; thence to and along that boundary and the western and northern boundaries generally of Sections 7, 13, and 8 to Mona Trig. Station; thence along the western and northern boundaries of Section 9, the southern and eastern boundaries of Lot 2 of Section 10, Block XI, the south-eastern and eastern boundaries of Sections 3 and 1, Block VIII, Ohura Survey District, to the Ararimu Road; thence across that road and westerly along its northern side to the western boundary of Section 12, Block VIII aforesaid; thence northerly along the western boundaries of Section 12, Block VIII aforesaid, and Section 8, Block IV, Ohura Survey District, to the southernmost corner of Section 6, Block IV, Ohura Survey District; thence north-westerly along the south-western boundaries of Sections 6 and 4 of the said Block IV to the boundary between Blocks III and IV, Ohura Survey District; thence westerly and northerly along the said block boundary to its intersection with the southern boundary of Aria Survey District; thence south-westerly and north-westerly along the said boundary to the middle of the Ohura River; thence northerly along the middle of the said river to a point in line with the north-eastern boundary of Section 15, Block XV, Aria Survey District; thence north-westerly in that line to and along the said north-eastern boundary to the southern boundary of Section 9, Block XV aforesaid; thence north-easterly and northerly along the southern and eastern boundaries of the said Section 9 to the Whenuakura Road; thence westerly along the southern side of the said road to a point in line with the eastern boundary of Section 13, Block XV, Aria Survey District; thence north-easterly in that line to and along the said boundary to the southern boundary of Section 21 of the aforesaid block; thence south-easterly and northerly along the southern and eastern boundaries of the said Section 21 to the northern boundary of Block XV, Aria Survey District; thence generally westerly along the said block boundary to the north-eastern boundary of Section 1, Block XIV, Aria Survey District; thence north-westerly generally along the said north-eastern boundary and the western boundary of Section 3, Block X, Aria Survey District, to Trig. Station Puketawai; thence along the southern and western boundaries of Section 9, and the southern boundary of Section 6, both of Block VI, Aria Survey District aforesaid, and along a right line being that last-mentioned boundary produced to the middle of the Waitewhena Road; thence southerly along the middle of that road to a point in line with the southern boundary of Section 8, Block V, Aria Survey District, and again westerly along a right line to and along the southern and western boundaries of that Section 8, the southern boundaries of Sections 3 and 2 of Block V, Aria Survey District aforesaid, and the eastern and southern boundaries of Section 11 of that Block V, to and along the western boundary of the Aria Survey District to the middle of the Panirau Stream; thence down the middle of that stream, to and down the middle of the Mokau River to a point in line with the north-eastern boundary of part Section 3, Block III, Mokau Survey District (scenic reserve), and along a right line to and along the north-eastern, eastern, and southern boundaries of that part Section 3, to and along the eastern and southern boundaries of Part Lot 13, D.P. 3049 (Taranaki Land Registry), the southern boundary of Lot 7, D.P. 3836 (Taranaki Land Registry), the southern and western boundaries of Lot 6, and the southern boundary of Lot 5, both on D.P. 3836 aforesaid, and along a right line being that last-mentioned boundary produced to the middle of the Mokau River aforesaid; thence again down the middle of that river to the sea; thence northerly generally along a right line and the sea coast, crossing the mouth of Kawhia Harbour, to the point of commencement.

Station K, Kaiaranga being the most northerly point of Lot 21, D.P. 1951; thence south-easterly generally along the north-eastern boundaries of the said Lot 21, D.P. 1951, to the northern boundary of Section 3, Block VIII, Tuahu Survey District; thence easterly along the northern boundary of the said Section 3 and of Section 1, Block VIII, Tuahu Survey District, to the north-eastern corner of the said Section 1; thence south-westerly along the south-eastern boundary of that section to a point in the middle of the Hangaroa Junction - Waikaremoana road; thence north-easterly along the middle of that road to the Bushy Knoll Road; thence south-easterly along the north-eastern boundary of that road to the north-west corner of Section 10, Block IX, Hangaroa Survey District; thence easterly and southerly along the northern and eastern boundaries of the said Section 10 to the Bushy Knoll Road aforesaid; thence southerly generally along the eastern side of the said road to a point opposite the eastern boundary of Section 11, Block IX, Hangaroa Survey District; thence southerly across the road to and along the last-mentioned boundary and the north-western boundary of Tauwharetoi 4b Block to the northernmost corner of that block; thence south-easterly along the north-eastern boundaries of Tauwharetoi 4b and 3b 1 Blocks, the north-western boundary of Section 2, Block XIV, Hangaroa Survey District, to the middle of the Hangaroa River; thence along the middle of that river to a point in line with the eastern boundary of Mangapoike 2A No. 2 Block in Block II, Opoiti Survey District; thence southerly to and along the eastern boundary of that block to Lot 4, D.P. 1938; thence north-easterly, easterly, and south-westerly along the north-western boundary of the said Lot 4, the northern and eastern boundaries of Lot 5, D.P. 1939, to the north-western boundary of Mangapoike part 2b Block; thence north-easterly along that boundary to connecting point K, M.L. Plan 1628d; thence southerly along a right line to connecting point F4, M.L. Plan 1628d, on the north-western boundary of Mangapoike 2f Block; thence north-easterly along the north-western boundary of the said Mangapoike 2f Block produced to the middle of the Mangarangiara Stream; thence south-easterly along the middle of the said Mangarangiara Stream to its junction with the Mangapoike River; thence north-easterly along the
