

middle of the said Mangapoike River to its intersection with the western boundary of Mangapoike B Block; thence southerly generally along the western boundary of Mangapoike B Block to and along the eastern boundaries of Lots 1 and 2, D.P. 1401, to the Mangapahi Road; thence easterly generally along the northern side of that road to the western boundary of Nuhaka 2B 2F Block; thence north-westerly along the western boundaries of that block and of Nuhaka 2B 2A 1 Block to the north-western corner thereof; thence north-easterly along the northern boundary of that block to its intersection with the south-western boundary of S.G.R. 40; thence north-westerly along that boundary to Trig. Station FX, Pukeronui; thence north-easterly along the north-western boundary of the said S.G.R. 40 to Trig. Station J, Pukehou; thence south-easterly along the north-eastern boundary of the said S.G.R. 40 to its intersection with Section 1, Block VI, Nuhaka North Survey District; thence south-westerly, easterly, and north-easterly along the north-western, southern, and south-eastern boundaries of the said Section 1, to its intersection with Maraetaha 2c Block; thence south-easterly along the northern boundary of S.G.R. 40 and of a closed road, again along the said northern boundary of S.G.R. 40 across a public road, and again along the said northern boundary of S.G.R. 40 to the middle of the Puninga Stream; thence southerly along the middle of that stream and the Nuhaka River for approximately 70 chains to a point in line with the east side of a public road; thence southerly generally to and along the east side of the said public road to its intersection with the north-eastern boundary of Section 2, Block XI, Nuhaka North Survey District; thence south-easterly along the north-eastern boundary of the said Section 2 to the north-western side of the Gisborne-Wairoa via Morere State Highway No. 49; thence north-easterly along the north-western boundary of the said highway to its intersection with the north-eastern boundary of Section 4, Block XI, Nuhaka North Survey District; thence south-easterly across the Gisborne-Wairoa via Morere State Highway No. 49 to the northernmost corner of Section 3, Block XI, Nuhaka North Survey District; thence in a southerly direction generally along the eastern boundary of that section and of Sections 12 and 20, Block XV, Nuhaka North Survey District, to the north-western corner of Paritu No. 3 Block; thence south-easterly generally along the northern and eastern boundaries of the said Paritu No. 3 Block and the north-eastern boundaries of Paritu 2B 2 and 2A Blocks to and across the Gisborne-Napier railway and again along the north-eastern boundary of Paritu 2A Block and that line produced to the middle of the Waiiau River; thence southerly generally along the middle of the said Waiiau River to a point in line with the north-eastern boundary of part Takararoa Block (D.P. 1759, Napier Registry); thence south-easterly generally to and along that boundary, across the Wharerata-Opoutama road and again along the said north-eastern boundary of the said part Takararoa Block (D.P. 1759, Napier Registry) to the sea coast; thence northerly and north-easterly generally along the sea coast to a point in line with the northern boundary of Kaiaua No. 1 Block in Block IV, Uawa Survey District; thence north-westerly and south-westerly generally along the boundary of the Electoral District of Bay of Plenty, hereinbefore described, to the point of commencement; and including all adjacent islands.

All that area bounded by a line commencing at a point in the middle of the Wanganui River in line with the northern boundary of Block I, Whirinaki Survey District; thence down the middle of the Wanganui River to its confluence with the Tangarakau Stream; thence along a right line to Trig. Station Whakaiahuwaka on Mount Humphries; thence along the western water shed of the Wanganui River to a point in line with the southern boundary of Block VII, Taurakawa Survey District; thence westerly along the southern boundaries of the said block and Block VI and its extension to the Koane Road; thence westerly along the northern side of Koane Road, the eastern boundary of Section 17, Block XII, Omoana Survey District, and northerly along the eastern side of the Moeawatea Road to a point in line with the northern boundary of Section 3, Block VIII, Omoana Survey District; thence to and westerly along the northern boundaries of Sections 3, 4, and 1, Block VIII aforesaid, to and across the Kawera Road, and westerly along the northern boundaries of Sections 21, 4, and part Section 1, Block VII, Omoana Survey District, to the Waitiri Road; thence northerly along the Waitiri Road to the south-western corner of part Section 14, Block VII, Omoana Survey District; thence northerly along the western boundary of the said part Section 14 to the southern boundary of part Section 8, Block II, Omoana Survey District; thence westerly along the said southern boundary of part Section 8 and generally southerly along the eastern boundaries of Sections 5s and 9s, Tawhiwhi Settlement; thence southerly along the eastern boundaries of part Lot 1, D.P. 1644, and part Lot 6, D.P. 2383; thence southerly and westerly along the eastern and southern boundaries of part Lot 7, D.P. 2358, to the Patea River; thence up the Patea River to a point in line with the northern boundary of Section 11, Block VIII, Ngaere Survey District; thence to and westerly and southerly along the northern and western boundaries of the said Section 11; thence westerly along the southern boundary of Block VIII, Ngaere Survey District, to Trig. Station B, Rahui; thence northerly generally along the eastern and northern boundaries of Lot 15, D.P. 577, and southerly and westerly along the eastern and southern boundaries of Lot 1, D.P. 2575, and south-westerly along the north-western boundary of Lot 15, D.P. 577, to the Pukengahu Road; thence generally northerly along that road to a point due west of Trig. Station B, Rahui; thence along a right line running due west to the north-western boundary of Lot 13, D.P. 577; thence south-westerly along that boundary to the northern boundary of Block XI, Ngaere Survey District, and north-westerly along that boundary to the northernmost corner of Section 35, Block XI, Ngaere Survey District, and south-westerly along the north-western boundary of that section to the Oru Road and southerly along that road to the Ngaere Road; thence generally westerly along the Ngaere Road and the Korepo Road to and westerly along the northern boundary of Block X, Ngaere Survey District, to the middle of the Waingongoro River, and generally northerly along the middle of that river to the middle of the Finnerty Road and generally westerly along the middle of that road, and south-easterly along the middle of the Hastings Road, to a point in line with the northern boundary of part Section 32, Block VIII, Kaipokonui Survey District; thence to and westerly and southerly along the northern and western boundaries of the said part Section 32 and westerly along the northern boundary of Section 31, Block VIII aforesaid, to and across the Duthie Road; thence north-westerly along that road and westerly along the northern boundary of Section 29, Block VIII aforesaid, and its production to the middle of the Palmer Road; thence generally southerly along that road to the north-eastern corner of Block XI, Kaipokonui Survey District; thence westerly along the northern boundaries of Blocks XI and X, Kaipokonui Survey District, to the south-eastern corner of Section 1, Block VI, Kaipokonui Survey District, and northerly along the eastern boundary of
