## RANGITIKEI

All that area bounded by a line commencing at a point in the middle of the Rangitikei River in line with the middle of Taylors Line in Block XIV, Rangitoto Survey District; thence northerly, easterly, and again northerly and easterly generally along the boundaries of the Electoral Districts of Patea and Waitomo, hereinbefore described, to a point in the middle of the Ngaruroro River on a right line between Trig. Station No. 26, Tauwheketewhango, and Trig. Station No. 65A; thence southerly generally along the middle of the said Ngaruroro River and the Taruarau River to a point in line with the south-western boundary of Block 78, Maraekakaho Crown Grant District, in Block VI, Ngaruroro Survey District; thence along a right line to Trig. Station Y in Block XII, Pukeokahu Survey District, and along the summit of the Ruahine Range to Trig. Station Tiraha, in Block III, Umutoi Survey District; thence north-westerly along a right line to Trig. Station Te Hekenga; thence along the south-western boundary of Awarua 1A3 South Block to the middle of the Oroua River; thence down the middle of that river to a point in line with the western boundary of Section 19, Block IV, Umutoi Survey District; thence to and along the western boundary of the said Section 19, across Table Flat Road to and along the western boundary of Section 29, Block IV aforesaid, and the production of the last-mentioned boundary to the middle of Coal Creek; thence down the middle of the Coal Creek to and down the middle of the Pohangina River to a point in line with the north-eastern boundary of Section 17, Block VI, Pohangina Survey District; thence to and along the north-eastern boundary of the said Section 17, across a public road to and along the north-eastern boundaries of Sections 32, 14, and 9, Block VI aforesaid, across a public road to and along the north-eastern boundaries of Sections 3 and 2, Block II, Pohangina Survey District; and the production of the last-mentioned boundary to the middle of the Oroua River; thence down the middle of that river to a point in line with the northern boundary of Kopane Settlement in Block V, Kairanga Survey District; thence to and along the northern boundary of Kopane Settlement, across a public road to and along the northern boundaries of Lots 1, 8, 9, 10, and 11, D.P. 2932, the northern and western boundaries of Lot 12 and the northern boundary of Lot 13, D.P. 2932, to a public road; thence along a right line to the easternmost corner of Section 23, Douglas Block; thence along the north-eastern boundaries of Sections 23, 22, 21, 20, 19, and 18, Douglas Block, across a public road to and along the north-eastern boundaries of Sections 9, 8, 7, 6, and 5, Douglas Block, across a public road to and along the north-eastern boundaries of Sections 4, 3, and 2 and the north-eastern and north-western boundaries of Section 1, Douglas Block to the easternmost corner of Section 34, Township of Carnarvon; thence along the north-eastern boundary of the said Section 34 to the Wanganui-Levin State Highway; thence north-easterly along the south-eastern side of that highway to the middle of Taylors Line; thence westerly along the middle of Taylors Line and its production to the point of commencement.

## HAWKE'S BAY

All that area bounded by a line commencing at a point on the sea coast, being the north-eastern corner of part Takararoa Block as shown on D.P. 1759, Napier Registry, and situated in Block XIII, Paritu Survey District; thence southerly, northerly, and again southerly generally along the sea coast to the southernmost corner of Block 3, Pourerere Crown Grant District, in Block II, Blackhead Survey District; thence north-westerly generally along the south-western boundaries of the said Block 3 and of Blocks 2A, 2, again Block 3, Blocks 25, 26, 9, and 28, Pourerere Crown Grant District, to the southernmost corner of Section 12, Block IX, Pourerere Survey District; thence along the south-western boundary of the said Section 12 to the southern side of a public road; thence along the south-eastern, north-eastern, and north-western sides of that road and Hiranui Road to and along the south-western boundary of the Tarawera Crown Grant District in Block XII, Motuotaraia Survey District, to and along the south-western boundary of Lot 1, D.P. 2761, to the westernmost corner of the said Lot 1; thence westerly generally along the southern boundaries of Lot 1, D.P. 3797, and Lot 1, D.P. 2762, and the western boundary of the last-mentioned lot to a point in line with the northern boundaries of Lot 20, Deeds Plan 52A, and Lot 9, Deeds Plan 52; thence along a right line to and along the said northern boundaries to the north-eastern corner of Lot 21, Deeds Plan 52A aforesaid; thence southerly along the eastern boundaries of the said Lot 21 and Lot 23, to the south-western corner of Lot 22; thence north-westerly along a right line to a point on Nicholls Road, being the southernmost corner of Lot 28, all the aforementioned lots being of Deeds Plan 52A aforesaid; thence along the south-western boundary of the said Lot 28 and its production to the middle of the Ngahape Stream; thence westerly generally along the middle of that stream to a point in line with the eastern boundary of Section I, Block XII, Takapau Survey District; thence along a right line to the north-eastern corner of the said Section I; thence along the southern boundaries of Sections 8 and 9, Block VIII, Takapau Survey District, and the production of the last-mentioned boundary to and up the middle of the Maharakeke Stream to a point in line with the northern boundary of Block 83, Porangahau Crown Grant District; thence along a right line to and along that northern boundary to the north-eastern corner of Section 1, Block XI, Takapau Survey District; thence along the northern and north-western boundaries of the last-mentioned section to the Mangapurakau Stream; thence along the middle of the Mangapurakau Stream to its confluence with the Waikopiro Stream; thence along the middle of the Waikopiro Stream to the Manawatu River; thence north-westerly along the middle of the Manawatu River to a point in Block I, Takapau Survey District, in line with the middle of a closed road as shown on plan S.O. 1157, green; thence
