

the boundary of St. James Run and passing through Mount Guinevere to Trig. Station Z on the western boundary of Block IX, Rainbow Survey District, being a point on the boundary of the Electoral District of Buller, hereinbefore described; thence north-easterly along the south-eastern boundary of that electoral district to and along the generally south-eastern boundary of the Electoral District of Nelson, hereinbefore described, to Pukerau Point, being the point of commencement; and including D'Urville Island, Arapaua Island, and all other adjacent islands.

HURUNUI

All that area bounded by a line commencing at a point on the sea coast in line with the south-western boundary of Rural Section 36498 in Block II, Weld Survey District, being a point on the boundary of the Electoral District of Marlborough, hereinbefore described; thence proceeding north-westerly generally along the boundary of that electoral district to Trig. Station Z on the western boundary of Block IX, Rainbow Survey District, being a point on the boundary of the Electoral District of Buller, hereinbefore described; thence south-westerly along that electoral district boundary to and along the south-eastern boundary of the Electoral District of Westland, hereinbefore described, to the junction of the summit of the Southern Alps with the summit of the Snowy Range; thence south-easterly generally along the summit of the Snowy Range through Roche Pass and Mount Crossley and the summit of the Dampier Range to Esk Head; thence along the summit of the range to Ashley Head; thence south-westerly along the summit of the Puketeraki Range to Trig. Station S in Block IX, Upper Ashley Survey District; thence due west to the middle of the Waimakariri River; thence down the middle of that river to and down the old dry bed of the south branch of the Waimakariri River to a point in line with the middle of Shipleys Road in Block VI, Christchurch Survey District; thence southerly to and along the middle of Shipleys Road to its junction with Waimakariri Road; thence north-easterly along the middle of Waimakariri Road to Sawyers Arms Road; thence south-easterly along the middle of Sawyers Arms Road to the eastern side of the South Island Main Trunk Railway; thence northerly along the eastern side of that railway to and easterly along the southern boundary of Rural Section 291, to the south-western corner of Lot 1, D.P. 16868; thence continuing easterly and northerly and again easterly along the southern boundary of the said Lot 1, D.P. 16868, and its production to the middle of the Main North Road; thence northerly along the middle of that road to its junction with Daniels Road; thence easterly along the middle of Daniels Road to its junction with Grimseys Road; thence southerly generally along the middle of that road to its junction with Winters Road; thence easterly and southerly along the middle of Winters Road and Philpotts Road to a point in line with the southern boundary of Lot 2, D.P. 2592; thence easterly along a right line to and along the southern boundaries of Lot 2 aforesaid, part R.S. 1118, and Lot 1, D.P. 6781, and its production to the middle of Hills Road; thence south-easterly along the middle of Hills Road, to and easterly along the middle of Briggs Road and Lake Terrace Road, to and northerly along the middle of Burwood Road, to and easterly along the middle of Travis Road, to and northerly along the middle of Frosts Road, to and easterly along the middle of Beach Road to a point in line with the eastern boundary of Lot 1, D.P. 5564; thence northerly to and along that boundary to the southern boundary of Reserve 4175; thence north-easterly generally along the southern boundary of Reserve 4175 and the southern and eastern boundaries of Lot 3, D.P. 11317, and along the northern side of Sylvia Street, the eastern boundary of Lot 1, D.P. 11317, the southern and eastern boundaries of Lot 2, D.P. 11317, the northern boundary of Lot 46, D.P. 6073, and its production to the middle of Bower Avenue; thence southerly and easterly along the middle of Bower Avenue and Florance Avenue to the western boundary of Reserve 1579; thence southerly along that boundary and the production thereof to the middle of Beach Road; thence easterly along the middle of that road and its production to the sea coast; thence north-easterly generally along the sea coast to a point in line with the south-western boundary of Rural Section 36498, Block II, Weld Survey District, being the point of commencement.

FENDALTON

All that area bounded by a line commencing at the intersection of Russley and Burnside Roads and proceeding north-easterly along the middle of Russley Road to its intersection with the middle of Waimakariri Road, being a point on the boundary of the Electoral District of Hurunui, hereinbefore described; thence south-easterly generally along the boundary of that electoral district to a point in the middle Philpotts Road in line with the southern boundary of Lot 2, D.P. 2592; thence south-westerly generally along a right line to and along the south-eastern boundary of Lot 10, D.P. 5998, to the southernmost corner of that lot; thence along a right line to and along the north-western boundary of Lot 10, D.P. 14816, and its production to the south-western side of Croziers Road; thence along the said south-western side to and along the north-western boundary of part Lot 1, D.P. 14947, to the westernmost corner of the said part lot; thence along a right line to a point on the south-western boundary of the land comprised in certificate of title, Volume 532, folio 60, Canterbury Registry, the said point being in line with the north-western side of Tomes Road; thence along another right line to a point on the north-eastern boundary of Lot 2, D.P. 14508, in line with the north-western side of Tomes Road; thence north-westerly and south-westerly along the north-eastern and north-western boundaries of the said Lot 2, and the north-western boundaries of Lots 5, 4, 3, and 2, D.P. 15533, to the middle of the Papanui Drain; thence north-westerly along the middle of the Papanui Drain to its intersection with the middle of Grants Road; thence south-westerly along the middle of Grants Road to its junction with the middle of Papanui Road; thence south-easterly along the middle of Papanui Road to its intersection with the middle of Bealey Avenue; thence westerly generally along the middle of Bealey Avenue, the middle of Harper Avenue, to and up the middle of the Avon River to the middle of Straven Road; thence southerly along the middle of Straven Road to a line parallel to and distant 250 links from and north of the northern side of Rata Street; thence westerly along the said line to the eastern boundary of the land (known as Riccarton Bush) shown on D.P. 3884; thence southerly and westerly generally along the eastern, south-eastern, and south-western boundaries of the land shown on the said D.P. 3884 to and along the north-eastern and north-western boundaries of Lot 309, D.P. 6079, to the north-western corner of that lot; thence northerly along a right line across Totara Street to the southern corner of Lot 310, D.P. 6079; thence north-easterly along the south-eastern boundaries of Lots 310 and 311 and northerly along
