## Ashburton

All that area bounded by a line commencing at a point on the sea coast in line with the middle of Chertsey Boundary Road, being a point on the boundary of the Electoral District of Selwyn, hereinbefore described; thence proceeding north-westerly along the south-western boundary of that electoral district to Whitcombe Pass; thence south-westerly along the summit of the Southern Alp to McClure Peak; thence along the summit of the Two Thumb Range to the source of Forest Creek; thence down the middle of Forest Creek to a poin in line with the southern boundary of Rural Section 36721 in Block X, Fox Survey District; thence to and along that boundary to the Phantom River thence down the middle of the Phantom River to its confluence with the Orari River; thence up the middle of the Orari River and the Mowbray Rive to a point in line with the north-western boundary of Section 26, Tripp Settlement; thence to and along that boundary and along the western boundary of Section 7a, Four Peaks Settlement, to the south-eastern boundary of Rural Section 36094; thence along that boundary and its production to the middle of the Opuha River; thence down the middle of the Opuha River to and of the Opuha River; thence down the middie of the Opuha River to and the sea coast to the point of commencement.

## Timard

All that area bounded by a line commencing at the middle of the mouth of the Opihi River; thence proceeding south-westerly to and along the sea coast to the middle of the mouth of the Pareora River; thence up the middle of that river to a point in line with the road forming the western boundary of Section 81, Rosewill Settlement; thence to and north-westerly along that road and Cannington Road to a point in line with. the road forming the northern boundary of Section 79, Rosewill Settlement, Block IX, Pareora Survey District thence easterly along that road to and along the southern side of Section 84 , Rosewill Settlement, to Summit Road; thence south-easterly along Summit Road to a point in line with the western boundary of Section 85, Rosewill Settlement; thence northerly and north-easterly to and along the western and north-western boundaries of the said Section 85 to Limestone Valley Road; thence easterly generally along Limestone Valley Road to Taiko Flat Road; thence easterly generally along Limestone Valley Road to Taiko Flat Road; thence northerly along Taiko Flat Road to the road forming the northern
boundary of Section 104, Rosewill Settlement; thence easterly generally along boundary of Section 104, Rosewill Settlement; thence easterly generally along
that road to and along the road forming the northern boundary of Rural that road to and along the road forming the northern boundary of Rura
Section 15758 to a point in line with the western boundary of Section 117 Rosewill Settlement; thence northerly generally to and along that boundary, the western boundary of Section 116, Rosewill Settlement, to and along Rolling Ridges Road, to and along the road intersecting Section 113, Rosewill Settlement, and forming the western boundaries of Rural Sections 18926, 18925, and Papaka Settlement, to and north-easterly along the road forming the northwestern boundary of Section 1, Papaka Settlement, Block VIII, Pareora Survey District, to and along the road intersecting Rural Section 12875 and forming the north-western boundaries of Rural Sections 18765, 12842, 16545, 13743, and 14284 , Block VIII, Pareora Survey District, to the Timaru-Pleasant Point main road; thence north-westerly along that road to Butlers Road; thence main road; thence north-westerly along that road to Butlers Road; thence boundary of Rural Section 22302; thence north-westerly along that boundary to the westernmost corner of the said Rural Section 22302; thence along a right line to the middle of the Opihi River; thence down the middle of that river to the point of commencement; and including all wharves and other extensions seaward.

## Waitaki

All that area bounded by a line commencing at a point on the sea coast due east of the junction of the Awamoa Central Road and the OamaruWaianakarua Main Highway in Block IV, Oamaru Survey District; thence north-easterly generally along the sea coast to the middle of the mouth of the Pareora River, being a point on the boundary of the Electoral District of Timaru, hereinbefore described; thence north-westerly and north-easterly gen erally along the south-western and north-western boundaries of that electoral district to and north-westerly generally along the boundary of the Electoral District of Ashburton, hereinbefore described, to the summit of the Southern Alps at McClure Peak; thence south-westerly along the summit of the Southern Alps at McClure Peak; thence south-westerly along the summit of the Southern Alps to Mount Strauchon; thence southerly along the watershed between the
Ahuriri and Hunter Rivers, passing through Mounts Huxley, Gladwish, and Martha to Longslip Peak; thence through the Lindis Pass to and along the summit of the Wether and St. Bathan's Ranges to Mount St. Bathans; thence along a right line due east to the summit of the Hawkdun Range; thence south-easterly along the summit of the Hawkdun Range, passing through Mount Ida, to the middle of the road from Mount Buster to Guffies Creek; thence northerly generally along the middle of that road to and down the middle of Guffies Creek and Otamatakau (Otematata) River to the Waitaki River; thence down the middle of the Waitaki River to a point in line with the eastern boundary of Blocks II and V, Awamoko Survey District; thence southerly to and along that boundary to the northern boundary of Section 15A, Plunket and along that boundary to the northern boundary of Section 15a, Plunket Settlement; thence easterly and southerly along the northern and eastern
boundaries of the said Section 15 A to a public road; thence easterly along that road to a point in line with the western boundary of Section 4 s , Pukenui Settlement; thence southerly generally to and along that boundary to the westerm boundary of Section 5 s , Pukenui Settlement; thence along the western, southern, eastern, and again southern boundaries of the said Section 5 s to the western boundary of the Papakaio Survey District; thence southerly along that boundary to the southern boundary of Block I, Papakaio Survey District; thence easterly along that boundary to the left bank of the Oamaru Creek; thence southerly down the left bank of that creek to the road forming the generally southern boundary of Section 70, Ardgowan Settlement; thence westerly along that road and its continuation to Parsons Road; thence southerly along Parsons Road to Tutu Hill Road; thence easterly generally along that road to and southerly along the road forming the western boundaries of Sections 95, 132 and 133, Ardgowan Settlement, to the road forming the northern boundaries of Lots 3 and 2, D.P. 4771; thence westerly along that road to White Rock Road; thence southerly along that road to Stonewall Road; thence easterly along that road to Awamoa Central Road; thence southerly generally along that road to its junction with the Oamaru-Waianakarua Main Highway; thence due east to the point of commencement; and including all wharves and other extensions seaward.
