

## NORTH DUNEDIN

All that area bounded by a line commencing at Trig. Station S, Swampy Spur; thence north-westerly along a straight line to Silver Peak Trig. Station, thence again north-westerly along a straight line to and along the western boundary of Block VII, Silverpeak Survey District, to the southern boundary of Block IX, Silver Peak Survey District; thence westerly and northerly along the southern and western boundaries of Block IX aforesaid to and generally south-westerly along the Three O'clock Stream to the southern corner of Section 5, Block VIII, Silverpeak Survey District; thence generally northerly and north-westerly along the western boundary of Section 5 aforesaid and Runs 171B, 171G, and 171C to Trig. Station D, Hummock; thence north-westerly along a straight line to a point on the eastern boundary of Block VII, Strath-Taieri Survey District, in a straight line between the Hummock and the south-eastern corner of Run 205E; thence generally northerly along the eastern boundary of the said Block VII to and easterly along the northern boundaries of Sections 19, 18, 22, and 23, Block VI, Budle Survey District, and across Nenthorn Creek to the western boundary of Run 121H; thence generally north-easterly and easterly along the north-western and northern boundaries of Runs 121H and 121G to the middle of the Waikouaiti River on the southern boundary of Section 8, Block I, Highlay Survey District; thence generally south-easterly along the middle of the Waikouaiti River to a point in line with the southern boundary of Block I, Dunback Survey District; thence generally easterly to and along the southern boundaries of Dunback and Moeraki Survey Districts to the eastern side of the Timaru-Dunedin State Highway; thence generally southerly along the eastern side of the said road to Watkin Creek; thence generally south-easterly along the eastern bank of that creek and Pleasant River to the sea coast; thence southerly generally along the sea coast and the shore of Otago Harbour to the middle of the mouth of the Leith Canal; thence north-westerly generally along the middle of that canal to a point in line with the middle of Parry Street; thence to and along the middle of that street, Frederick Street, Pitt Street, Heriot Row, and Khyber Pass and its production to the middle of Queens Drive, along the middle of Queens Drive, Drivers Road, Balmacewan Road, Helensburgh Road, and Wakari Road to a point in line with the north-eastern boundary of Section 51, Wakari District; thence to and along the north-eastern boundary of the said Section 51 to the northernmost corner of Section 51 aforesaid; thence north-easterly along the north-western boundaries of Sections 53, 52, 54, 56, 58, 60, 62, 64, and 66 to the westernmost corner of Section 68, all of Wakari District; thence north-westerly along the south-western boundary of Section 58, Block V, Dunedin and East Taieri Survey District, and north-easterly along the north-western boundaries of Sections 58, 41, 42, 43, 44, and 45, Block V, Dunedin and East Taieri Survey District, to the northernmost corner of the last-mentioned section; thence northerly generally along the north-eastern boundary of Section 53, the eastern boundaries of Sections 54 and 55, across a road, the south-eastern boundary of Section 9, the eastern boundaries of Sections 10 and 11, across a road, and the eastern boundary of Section 3, all of Block V, Dunedin and East Taieri Survey District, to the point of commencement; and including Quarantine Island and other adjacent islands and all wharves and other extensions seaward.

## DUNEDIN CENTRAL

All that area bounded by a line commencing at a point on the shore of Otago Harbour in the middle of the mouth of the Leith Canal and proceeding south-westerly along the shore of Otago Harbour, including all wharves and other extensions seaward, to a point in line with the middle of Hillside Road; thence to and along the middle of Hillside Road to David Street; thence north-westerly along the middle of David Street to South Road; thence north-westerly along the middle of South Road to a point in line with the south-western side of Surrey Street; thence north-westerly along the production of the south-western side of Surrey Street to the middle of the South Island Main Trunk Railway, a straight line to the northernmost corner of Lot 35, D.P. 3700, part Section 64, Block VI, Town District, and along the western side of Forfar Street and its production to the middle of Mitchell Avenue; thence westerly along the middle of Mitchell Avenue to Glenpark Avenue; thence northerly along the middle of Glenpark Avenue, Laurie Street, Brunel Street, Mailer Street, and McCrea Street to Meadow Street; thence westerly generally along the middle of Meadow Street, Hawthorne Avenue, Kenmure Road, and Stone Street to the generally western boundary of Block IX, Dunedin and East Taieri Survey District; thence southerly along that boundary to the easternmost corner of Section 18, Lower Kaikorai Survey District; thence westerly generally along the north-eastern boundary of Section 18 aforesaid to and down the left bank of the Kaikorai Stream, to and along the north-eastern boundary of Section 19, Lower Kaikorai Survey District, to the south-eastern boundary of Section 1 of 49, Block VI, Dunedin and East Taieri Survey District; thence north-easterly along the south-eastern boundary of Section 1 aforesaid to its easternmost corner; thence north-westerly along the north-eastern boundaries of Sections 1 of 49 and 2 of 49 and generally northerly along the south-eastern boundary of Section 84 and the southern and eastern boundary of Section 57, Block VI, Dunedin and East Taieri Survey District, to and across a road; thence generally westerly along the southern boundaries of Sections 146, 148, 150, 152, 153 and the south-western boundary of Section 154, Wakari Survey District, and across Dalziel Road to the southernmost corner of Section 155, Wakari Survey District; thence westerly along the northern side of the road forming the southern boundary of Section 155 aforesaid and passing through Section 52, Block VI, Dunedin and East Taieri Survey District, to the south-western boundary of the said Section 52; thence to and along that boundary to the south-eastern boundary of Section 1 of 27, Block VI aforesaid; thence north-easterly along the south-eastern boundaries of Sections 1 of 27 and 2 of 27, Block VI aforesaid, the south-eastern and north-eastern boundaries of Section 50, Block VI aforesaid, and the production of the last-mentioned boundary to the middle of a public road; thence north-easterly along the middle of that road to a point in line with the middle of Half-way Bush Road; thence to and along the middle of that road to a point in line with the south-eastern boundary of Section 31, Block V, Dunedin and East Taieri Survey District; thence to and along that boundary, the south-western boundaries of Sections 2 of 32, 1 of 32, the abutment of a closed road, the southern boundary of part Section 57, Block V aforesaid, the southern side of a road, the southern boundaries of part Section 57 and Section 56, and the southern and south-eastern boundaries of Section 59, all of Block V aforesaid, to the northernmost corner of Section 51, Wakari Survey District; thence south-easterly generally along the boundary of the Electoral District of North Dunedin hereinbefore described, to the point of commencement.
