*Alteration of Roads Council Districts*

PURSUANT to section 7 of the National Roads Act 1953, notice is hereby given that the following resolution was passed by the National Roads Board on the 22nd day of February 1957.

The National Roads Board hereby resolves that on and from the 1st day of April 1957:

1. No. 2B Roads Council District, as constituted by resolution of the Main Highways Board on 19 June 1946,\* shall cease to be a Roads Council District.

2. The area described in the First Schedule hereto is hereby constituted a Roads Council District and shall be known as No. 2B Roads Council District.

3. The area described in the Second Schedule hereto is hereby constituted a Roads Council District and shall be known as No. 2c Roads Council District.
