PURSUANT to the Forest and Rural Fires Act 1955, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

This order may be cited as the Tokoroa Rural Fire District Order 1948, Amendment No. 3, and shall be read together with and deemed part of the Tokoroa Rural Fire District Order 1948* (hereinafter referred to as the principal order).
 The principal order may hereafter be cited as the Tokoroa Rural Fire District Order 1948.
 The principal order is hereby amended by revoking the First and Second Schedules and substituting the First and Second Schedules

set out in the Schedule to this order.

SCHEDULE

NEW SCHEDULES TO PRINCIPAL ORDER

"FIRST SCHEDULE

"South Auckland Land District - Rotorua Conservancy

"ALL that area in Matamata, Rotorua, Otorohanga, and Taupo Counties, containing approximately 283,000 acres, situated in Patetere North, Patetere South, Wharepapa, Horohoro West, Horohoro, Ngautuku, Ranginui, Whakamaru, Te-Ati-a-muri, Ngongotaha, Marotiri, Tuhingamata West, Tuhingamata East, and Tatua Survey Districts, and bounded generally as follows: Commencing at the easternmost corner of part of the Kokako Block, Block XVI, Patetere North Survey District; thence by a right line to the north-eastern corner of Section 45, Selwyn Settlement, by Te Ranga No. 3 Block to the Korakonui Stream; thence by a right line to a point on the Mokaihaha Stream opposite the north-eastern corner of Te Whetu No. 3B 2 Block; thence by the Mokaihaha Stream and Patetere South No. 2 Block to the south-eastern corner of Te Whetu No. 3B Block to the south-eastern corner; thence by a right line to the junction of the eastern boundary of Patetere South No. 2 Block with the porthern side of the Potherway Road; thence by the northern side of the aforesaid road to its junction suth-eastern corner of Te Whetu No. 3a 4 Block; thence by a right line to the easternmost corner of Section 1, Block II, Horohoro West Survey District, by Patetere South No. 2 Block with the northern side of the Pokaiwhenua Road; thence by the northern side of the aforesaid road to its junction with the Mamaku Road; thence by a right line to the northerastern corner of Te Rimu Horohoro Block, and by a right line to the northernmost corner of Section 7, Block XIV, Horohoro Survey District; towards the south-east by the south-eastern side of the Rotorua-Atiamuri Main Highway to the bridge over the Taahunaatara Stream; towards the north-east by a right line between the last-mentioned point and the westernmost corner of Section 3, Block I, Ngongotaha Survey District, to a point 40 chains distant from the Rotorua-Atiamuri Main Highway; towards the south-east by lines 40 chains distant from and parallel to the aforesaid main highway and the Whangapoua Stream; towards the south-east by lines 40 chains distant from and parallel to the eastern boundary of Lot 3 on D.P. 16299; towards the north-east by a line 40 chains distant from and parallel to the right bank of the Waikato River, by the crossing of that river, by Tauri No. 3a Block, and by Lot 2 on D.P. 16198 to its south-western corner; thence by a right line due west to the Waitoa-Taupo Main Highway, by Cardon D.P. 16198 to its south-western corner; thence by a right line due west to the Waitoa-Taupo Main Highway, by Cardon D.P. 16198 to its south-east by part of Oruanui No. 6 Block; towards the south-east generally by Whangamana 2e la and 2a 2a 1 Blocks; towards the south-east by part of Oruanui No. 6 Block; towards the south-east by Pouakani B 6a No. 8 Block; towards the west, south-west, and north-west by Tihoi No. 4b Block; again towards the west generally by Pouakani B 6a No. 8 Block to and across a road; towards the north-west by the north-west by right lines parallel to and 40 chains distant from Tatua West Block to Whakamaru Lake to the Wainaakino Othewster Matamuku part No. 3 Block to Stringer Road; towards the west by Stringer Road; towards the south-west generally by Matamuku part No. 3, and part No. 1A 2 Blocks, Waotu South C No. 10 Block, the western side of Waotu South Road, the Te Awamutu Road, and Waotu North part 2A 3 Block; towards the north-west by Waotu North 2B 2 Block; towards the northern side of a road; towards the north-east by the north-eastern side of the Waotu-Lichfield Road, and by part of Waotu North C 4 Block; towards the north-west by Waotu North C 4 and 2J 3C Blocks; towards the north-east by Lot 8 on D.P. 24182; towards the north-west by Lots 8 and 7 on D.P. 24182 and Lots 2 and 1 on D.P. 24885; towards the north-east by a right line from the easternmost corner of Lot 1 aforesaid to the north-eastern corner for Lot 2 aforesaid to the north-eastern corner for Lot Lots 2 and 1 on D.P. 24885; towards the north-east by a right line from the easternmost corner of Lot 1 aroresaid to the north-eastern corner of part of Lot 1 on D.P. 13665; thence by a right line to the north-western corner of Lot 2 on D.P. 23248 and by Lots 2 and 3 on D.P. 23248; towards the north by Lot 3 aforesaid; towards the east by Section 43B, Selwyn Settlement, and the western boundary of the Pakuranga Block produced to the old Cambridge-Taupo Road; towards the north-east by the north-eastern side of the last-mentioned road to the south-ernmost corner of Lot 21 on D.P. 23865; thence by Lot 21 aforesaid and by the Matarawa Stream; towards the north-west by the n part of Kokako Block to a point 40 chains north of the Ngutuwera Stream; towards the north by a right line due east to the south-eastern boundary of part of Kokako Block; and towards the north-west by the last-mentioned block. As shown on plan No. 37/18 deposited in the Head Office of the New Zealand Forest Service at Wellington, and thereon bordered red."
