A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Charles John, Viscount Cobham, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the First Schedule hereto, subject to the reservations as to coal, gold, and silver, as endorsed on the respective certificates of title, and the land described in the Second Schedule hereto is hereby taken for soil conservation and river control purposes, and shall vest in the Manawatu Catchment Board as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 13th day of January 1958.
