

## WAIMATUA RABBIT BOARD

## RESOLUTION MAKING SPECIAL RATE

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act 1926, the Waimatua Rabbit Board hereby resolves as follows:

"That, for the purpose of providing interest and other charges on a loan of £3,500 authorised to be raised by the Local Government Loans Board under the above-mentioned Act for the purpose of erecting a dwellinghouse, the Waimatua Rabbit Board hereby makes and levies a special rate of 0.685 pence per acre on all the rateable property of the Waimatua Rabbit District; and that the special rate shall be an annually recurring rate during the currency of such loan, being payable on the 30th day of April in each and every year during the currency of such loan, being a period of 25 years, or until the loan is fully paid off."

## RESOLUTION MAKING SPECIAL RATE

*Hunua Additional Loan 1958, £796,000*

THAT in pursuance and exercise of the powers vested in it in that behalf by the Municipal Corporations Act 1954 and amendments, the Local Authorities Loans Act 1956, and of all other powers thereunto enabling it, the Auckland City Council hereby resolves as follows:

"That, for the purpose of providing interest and other charges on a loan of seven hundred and ninety-six thousand pounds (£796,000) to be known as the Hunua Additional Loan 1958, which amount is proposed to be raised by the Auckland City Council under the above-mentioned Acts for the purpose of meeting additional costs and construction work in the waterworks development scheme at Hunua and the cost of raising the loan, the said Auckland City Council hereby makes and levies a special rate of one and thirteen sixteenths pence ( $1\frac{13}{16}$  of 1d.) in the pound (£) upon the rateable value (on the basis of the annual value) of all rateable property of Auckland City comprising the whole of the City of Auckland; and that the said special rate shall be an annual-recurring rate during the currency of such loan and shall be payable on the first day of June in each and every year during the currency of the said loan or until the loan is fully paid off."
