Limited Speed Zone Declared

1. So much of the Warrant under section 3 of the Motor Vehicles Amendment Act 1936, dated the 19th day of September 1938,* as relates to part of the Riverton-Otautau-Nightcaps Main Highway at Otautau is hereby revoked.

2. The portion of road specified in the Schedule to this notice is hereby excluded from the limitation as to speed imposed by section 36 of the Transport Act 1949.

3. The portion of road specified in the Schedule to this notice is hereby declared to be a limited speed zone for the purpose of the Traffic Regulations 1956.†
